RESOLUTION CERTIFYING THE MILEAGE IN THE COUNTY OF SAN MATEO'S MAINTAINED ROAD SYSTEM TO BE 315.791 MILES AS OF DECEMBER 31, 2014 (PROJECT NO. R3001, F-331 [3C])

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Section 2121 of the California Streets and Highway Code provides that each year counties shall submit to the California Department of Transportation the additions to and deletions from their total mileage of maintained county roads; and

WHEREAS, the California Department of Transportation certified to the State

Controller that the total mileage of maintained County roads in the County of San

Mateo, as of December 31, 2013, was 315.447 miles; and

WHEREAS, the Director of Public Works has reported that as of December 31, 2014, there was a net increase to the total mileage of maintained County roads during 2014; and

WHEREAS, the Director of Public Works has also reported that as of December 31, 2014, the total mileage of maintained County roads is 315.791 miles.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED based on the information provided by the Director of Public Works, that this Board certifies the County maintained mileage as described in Exhibit "A", "Summary of County of San Mateo Maintained Road Mileage as of December 31, 2014" attached hereto and made a part hereof, which indicates that the mileage of County of San Mateo maintained roads as of December 31, 2014 is 315.791 miles.

- O'NEILL AVENUE (1/2 width) (County Road Number 400), Harbor/Industrial Area, from Section 1: Elmer Street (County Road Number 417) to County Boundary 25 feet west of Granada Street, and Section 2: County Boundary 25 feet East of Granada Street to County Boundary before Karen Road, was relogged. The County maintained mileage has increased 0.192 centerline miles or 1,013.76 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.272 centerline miles or 1,436.16 feet.
- AVENUE PORTOLA (County Road Number 916), El Granada Area, from Obispo Road (County Road Number 105-C) to the end, east of Del Monte Road (County Road Number 945-A), was re-logged. The County maintained mileage has increased 0.107 centerline miles or 564.96 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.807 centerline miles or 4,260.96 feet.
- CUESTA REAL (County Road Number 1551-A), La Honda Area, from Entrada Way (County Road Number 696) to Canada Vista Drive (County Road Number 1563-B), was re-logged. The County maintained mileage has increased 0.045 centerline miles or 237.60 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.215 centerline miles or 1,135.20 feet.
