RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC WORKS
TO PROCEED WITH: A) USING THE APPROXIMATE CENTER OF THE
EXISTING ROAD AS THE CENTER OF THE MINIMUM ROAD IMPROVEMENTS
THAT ARE PROPOSED TO BE CONSTRUCTED ON LIBERTY PARK AVENUE
FROM LUCKY AVENUE TO CLOUD AVENUE; AND B) PREPARING PLANS
AND SPECIFICATIONS FOR THE RECONSTRUCTION OF LUCKY AVENUE,
FROM AVY AVENUE TO SHARON ROAD, AND LIBERTY PARK AVENUE,
FROM ALAMEDA DE LAS PULGAS TO CLOUD AVENUE; AND
C) ADVERTISING FOR BIDS FOR THE ABOVE DEFINED ROAD
RECONSTRUCTION PROJECT

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on August 19, 1997, this Board adopted Resolution Nos. 061312 and 061313, which established minimum road standard options and a priority list for road improvements in the West Menlo Park area; and

**WHEREAS**, on May 18, 1999, this Board adopted Resolution No. 062821, which adopted procedures to be used by the Department to determine if property owners want minimum road improvements built on a specific street and the minimum road standard to be used in the design of the road improvements; and

WHEREAS, on January 7, 2003, this Board adopted Resolution Nos. 065763 and 065764, which revised the type of curbing to be used in conjunction with minimum road standards in the West Menlo Park area and revised the procedures for determining minimum road standard options, respectively; and

WHEREAS, this Board adopted procedures to be used by the Department of Public Works whereby the center of proposed road improvements should be conterminous with the center line of the road right-of-way unless there are conflicts with existing facilities or obstructions in the roadway area; and

**WHEREAS**, the existing centerline of Liberty Park Avenue from Lucky Avenue to Cloud Avenue is offset from the centerline of the road right-of-way; and

WHEREAS, the majority of property owners on Liberty Park Avenue from Lucky Avenue to Cloud Avenue requested that the existing centerline of the road be used as the centerline of the proposed road improvements; and

**WHEREAS**, the Director of Public Works has evaluated the request and considered the impacts to the adjacent properties, existing drainage patterns, and existing improvements; and

WHEREAS, the Director of Public Works has recommended using the centerline of the existing road as the approximate centerline for the proposed road improvements on Liberty Park Avenue from Lucky Avenue to Cloud Avenue; and

WHEREAS, the Department has surveyed the property owners along Liberty
Park Avenue and Lucky Avenue to determine whether they are in favor of road
improvements and if so, which minimum road standards to design and construct and
conducted two property owner meetings to explain the options and answer questions;

**WHEREAS**, based on the property owner survey results, the following minimum road standards are to be used:

- Lucky Avenue from Avy Avenue to Liberty Park Avenue 11-foot wide travel lane with 3-foot wide valley gutter on one side of the street (north side). The existing curb, gutter and sidewalk on the opposite side of this street would remain and the project would conform to these existing improvements;
- Lucky Avenue from Liberty Park Avenue to Sharon Road two 9-foot
   wide travel lanes with 3-foot wide valley gutters on each side;
- Liberty Park Avenue from Alameda de las Pulgas to Lucky Avenue 11foot wide travel lane with 3-foot wide valley gutter on one side of the
  street (east side). The existing curb, gutter and sidewalk on the opposite
  side of this street would remain and the project would conform to these
  existing improvements;
- Liberty Park Avenue from Lucky Avenue to Cloud Avenue two 9-foot wide travel lanes with 3-foot wide valley gutters on each side using the approximate centerline of the existing roadway for the road improvements; and

WHEREAS, the Director of Public Works has recommended that this Board authorize the preparation of the plans and specifications and call for bids for this Project in order to reduce the time required to proceed through the contract bid and award process for the Reconstruction of Lucky Avenue (from Avy Avenue to Sharon Road)

and Liberty Park Avenue (from Alameda de las Pulgas to Cloud Avenue); and

**WHEREAS**, the Board has considered and concurs in the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Director of Public Works is:

- A. Authorized to use the approximate center of the existing road as the center of the minimum improvements that are proposed to be constructed on Liberty Park Avenue from Lucky Avenue to Cloud Avenue.
- B. Authorized to proceed with preparing plans and specifications and call for bids for the above defined road reconstruction project to the minimum road standards stated herein.
- C. Directed to advertise for bids for the above defined road reconstruction project, and to report to this Board with recommendations on awarding the contract to the lowest responsible bidder for said project once bids are received and confirmed.
