Upon his retirement from the

WHEREAS, Lieutenant Timothy Reid began a distinguished nearly three decade long career with the San Mateo County Sheriff's Department on April 17, 1989 after serving as Deputy Sheriff in the San Francisco Sheriff's Department and honorable service in the United States Armed Forces including a tour of duty in Operation Desert Storm followed by 22 years in the United States of America Army Reserve; and

WHEREAS, Lieutenant Timothy Reid has demonstrated exemplary service to the San Mateo County Sheriff's Department moving quickly through the ranks beginning his career in the Fourth Floor Jail, the Patrol Division, Transportation Unit and Maguire Correctional Facility and due to his outstanding performance was appointed Recruit Training Officer for the Regional Basic Police Academy - an assignment that he excelled at and led to his promotion to Sergeant in the Corrections Division; and

WHEREAS, Lieutenant Timothy Reid continued to demonstrate a clear talent for management and working with the public and as a result was asked to serve as the first full-time Rangemaster for the Sheriff's Office where he implemented numerous training regiments and established a robust firearm management control system; and

WHEREAS, Lieutenant Timothy Reid, having earned the respect of the county community and the esteem of his peers in the Sheriff's Office, was promoted to the notable and supervisorial role of Lieutenant within the Maguire Correction Facility where he was selected Facility Commander overseeing all administrative responsibilities for the complex and was later assigned to oversee Patrol Operations in the South County Area of Command, a role he excelled at until his retirement on March 25, 2015; and

WHEREAS, Lieutenant Timothy Reid has received numerous awards and commendations including a Medal of Valor for his heroic and unselfish off-duty performance during the 2010 San Bruno pipeline explosion and The Sons of the American Revolution Medal of Heroism; and

WHEREAS, Lieutenant Timothy Reid during his illustrious career has made significant contributions to the safety and well-being of the residents of the San Mateo County community.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of San Mateo County congratulates and commends Lieutenant Timothy Reid upon his retirement from the San Mateo County Sheriff's Department.
