RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO: A) FILE A NOTICE OF EXEMPTION FOR A CALIFORNIA ENVIRONMENTAL QUALITY ACT CATEGORICAL EXEMPTION FOR THE INSTALLATION OF SPEED CONTROL DEVICES ON CORAL REEF AVENUE, IN EL GRANADA; B) INSTALL SPEED CONTROL DEVICES ON CORAL REEF AVENUE, IN EL GRANADA; AND C) MONITOR THE EFFECTIVENESS OF THE SPEED CONTROL DEVICES AND EVALUATE ANY IMPACTS THAT THE INSTALLATION OF THE SPEED CONTROL DEVICES MAY HAVE ON TRAFFIC ON OTHER COUNTY-MAINTAINED ROADS IN THE IMMEDIATE AREA

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board adopted the Residential Speed Control Program (“Program”) date April 11, 2005; and

WHEREAS, The majority of property owners along Coral Reef Avenue between Sonora Avenue and Bridgeport Drive signed a petition requesting the installation of speed control devices to help control the speed of traffic on their street; and

WHEREAS, the Department of Public Works, based on traffic surveys, has determined that Coral Reef Avenue between Sonora Avenue and Bridgeport Drive meets the criteria in the Program for the installation of speed control devices; and

WHEREAS, Department of Public Works has determined that this project qualifies for a Categorical Exemption pursuant to Section 15301(f) of the California Environmental Quality Act (CEQA) Guidelines for Implementation, which provides that addition of safety or health protection devices for use during construction of or in

conjunction with existing structures, facilities, or mechanical equipment, or topographical features including navigational devices; is exempt from review; and

WHEREAS, the Director of Public Works has recommended that two (2) speed control devices be installed on Coral Reef Avenue; and

WHEREAS, this Board has reviewed and concurs in the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Director of Public Works is:

- A. Authorized to file a Notice of Exemption for a California Environmental Quality Act Categorical Exemption.
- B. Authorized to proceed with the construction of speed control devices along Coral Reef Avenue between Sonora Avenue and Bridgeport Drive, as provided by the Program and as approved by this Board.
- C. Directed to monitor the effectiveness of the speed control devices and evaluate any impacts that the installation of the speed control devices may have on traffic on other County maintained roads in the immediate area.
