RESOLUTION: A. ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH FEDERAL PREVAILING WAGE SCALE REQUIREMENTS, FOR THE RECONSTRUCTION OF COUNTY BRIDGE NO. 67 (STATE BRIDGE NO. 35C-043) ON THE LOWER CRYSTAL SPRINGS DAM IN THE UNINCORPORATED AREA OF SAN MATEO COUNTY; AND B. AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY THURSDAY, OCTOBER 1, 2015 AT 2:30 P.M. IN THE OFFICE OF THE COUNTY MANAGER/CLERK OF THE BOARD OF SUPERVISORS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, on October 16, 2007, this Board adopted Resolution No. 069064,

which authorized the execution of an Agreement for Engineering Services with Parsons

Brinckerhoff, Inc., formerly PB Americas, Inc., in connection with the preparation of

design plans and specifications for the Crystal Springs Dam Bridge (CSDB)

Replacement Project; and

WHEREAS, on May 6, 2008, this Board adopted Resolution No. 069402, which

authorized an Agreement with Pacific Gas and Electric Company (PG&E) for the construction and cost responsibilities associated with PG&E's 230kV transmission line in connection with the CSDB Replacement Project; and

WHEREAS, on December 1, 2009, this Board adopted Resolution No. 070543, which certified the Mitigated Negative Declaration for the CSDB Replacement Project,

which included the demolition and removal of the existing bridge and construction of the replacement bridge; and

WHEREAS, on June 8, 2010, this Board adopted Resolution No. 070855, which adopted plans and specifications, and authorized the Director of Public Works to call for sealed proposals for the demolition of the CSDB on top of the Lower Crystal Springs Dam; and

WHEREAS, on July 27, 2010, this Board adopted Resolution No. 070961, which authorized an Agreement with Ferma Corporation for the demolition of the CSDB on top of the Lower Crystal Springs Dam; and

WHEREAS, the San Francisco Public Utilities Commission (SFPUC), the owner of the Lower Crystal Springs Dam upon which the bridge sat, began construction of their dam improvements project and Crystal Springs/San Andreas Transmission System Upgrades Project once the bridge was removed. These projects were completed in May 2012 and October 2014, respectively, enabling the County to move forward with construction of the CSDB Replacement Project; and

WHEREAS, on January 27, 2015, this Board adopted Resolution No. 073622, which authorized an amendment to the Agreement with PG&E specifying the revised location of the 230kV transmission line to be under the bridge soffit (downstream outside edge of the bridge) instead of within the bridge structure; and

WHEREAS, on February 10, 2015, this Board adopted Resolution No. 073654,

which authorized the execution of a Memorandum of Agreement with the San Francisco Public Utilities Commission (SFPUC) regarding the construction and cost responsibilities associated with work to be performed by the County for the SFPUC in connection with the CSDB Replacement Project; and

WHEREAS, the County of San Mateo applied for and has been approved to receive Federal Highway Bridge Replacement and Rehabilitation funds from the Federal Highway Administration, administered by Caltrans, for the reconstruction of this Countyowned bridge and recently received authorization to proceed with the construction for this project from the Federal Highway Administration; and

WHEREAS, plans and specifications dated April 29, 2015 have been prepared and approved by the Director of Public Works for the above mentioned project, and said plans and specifications have been filed in the office of the Director of Public Works (the "plans and specifications"); and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the U.S. Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of worker needed to execute the contract.;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. The plans and specifications dated April 29, 2015, for the aforesaid project, which are on file in the office of the Director of Public Works, and to which

reference is hereby made for further particulars, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for the improvements described therein.

- 2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the U.S. Department of Labor on federally funded projects, in the locality in which said work is to be performed for each type of worker needed to execute the contract.
- 3. The Department of Public Works is authorized and directed to issue a call for sealed proposals and to set the bid opening date and time on or before 2:30 p.m., Thursday, October 1, 2015 in the office of the County Manager/Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Said bids will be received by the Deputy Clerk of the Board of Supervisors and then transmitted to the County Manager's Office in said Hall of Justice and be publicly opened and declared.
- 4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
- 5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for four (4) times in a newspaper receiving wide local circulation, published in the County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
