RESOLUTION HONORING AND COMMENDING**

CORINA MARIE SHORTALL-ENRIQUEZ 2015 Women in County Government Public Service – The Extra Mile Award Recipient

WHEREAS, as a Case Worker with Service Connect, CORINA MARIE SHORTALL-ENRIQUEZ works closely with Probation, Correctional Health, the Sheriff’s Office, and the Human Services Agency in giving many layers of support, education, and advocacy to improve local reentry and public safety by promoting personal recovery and rehabilitation, as she continues to live them herself, as both a graduate and permanent staff member of the program; and

WHEREAS, CORINA MARIE SHORTALL-ENRIQUEZ assists clients from the point of pre-release through re-entry and rehabilitation by engaging them with respect, listening thoughtfully, introducing them to an array of services, walking with them step-by-step on the path to recovery while always looking for new solutions to meet their challenges and acting with initiative to make sure success happens; and

WHEREAS, while CORINA MARIE SHORTALL-ENRIQUEZ reliably fulfills all routine tasks of employment, she often initiates projects that fills an unmet need by identifying resources, developing and enacting a plan that connects clients, then evaluating and refining it for ongoing success; and

WHEREAS, CORINA MARIE SHORTALL-ENRIQUEZ, throughout these efforts, effectively holds clients accountable for committing to the changes that they have identified as goals for themselves by honoring their self-determination, conveying both empathy for their experience and encouragement to keep learning, getting better, and doing better; and

WHEREAS, CORINA MARIE SHORTALL-ENRIQUEZ began a “Wall of Hope” which displays photographs and brief statements from clients and staff on a community room wall and she started an art group, which contributed to an exhibit in the Hall of Justice for Recovery Happens Month wherein she volunteered to invite, coordinate, collect, and transport all of the art contributions for this show; and

WHEREAS, although she acknowledges that public speaking prompts anxiety within her, she has with grace and humility accepted opportunities to educate and present to many audiences including behavioral health leadership, educational institutions and a state subcommittee.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of San Mateo, State of California, hereby commends CORINA MARIE SHORTALL-ENRIQUEZ, 2015 Women in County Government Public Service – The Extra Mile Award Recipient, for her exemplary leadership and commitment to the community in San Mateo County.
