RESOLUTION AUTHORIZING: A) THE ESTABLISHMENT OF "NO OVERNIGHT PARKING" ZONES AT THE SAN CARLOS AND HALF MOON BAY AIRPORTS BETWEEN THE HOURS OF 11 P.M. AND 6 A.M.; AND B) THE ESTABLISHMENT OF "OVERNIGHT PARKING" ZONES AT THE SAN CARLOS AND HALF MOON BAY AIRPORTS FOR USE WITH A VALID PERMIT FOR A MAXIMUM PERIOD OF SEVEN CONSECUTIVE DAYS WITHOUT THE WRITTEN PERMISSION OF THE AIRPORT MANAGER; AND C) THE ADOPTION OF A COUNTY AIRPORT PARKING POLICY; AND D) THE DIRECTOR OF PUBLIC WORKS, OR HIS DESIGNEE, TO ISSUE ADMINISTRATIVE PENALTIES AND/OR CITATIONS FOR VIOLATIONS OF THE COUNTY'S PARKING ORDINANCE

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, tools are needed to more effectively address impacts from long-

term parking at the County of San Mateo's two airports (in San Carlos and Half Moon

Bay) and to ensure that long-term parking does not result in a lack of access to parking

for Airport-based businesses, customers, and the general public; and

WHEREAS, designating areas for long-term and day-use parking is a common

airport practice, is easily recognizable by the public, and provides efficiencies in

administration and enforcement; and

WHEREAS, State law and local ordinances including, California Vehicle Code Sections 21113 et. al. and 22651.3, and Chapters 1.08, 7.28, and 7.32 of the San Mateo County Ordinance Code collectively allow the Board of Supervisors to establish parking controls and issue citations for parking violations on County-controlled lots; and **WHEREAS**, the Director of Public Works recommends the adoption of a County Airport Parking Policy and the establishment of overnight and day-use parking zones.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that that effective February 1, 2016 the Board hereby authorizes:

- The adoption of a County Airport Parking Policy, attached hereto as Attachment A to this Resolution.
- 2. The establishment of "No Overnight Parking" zones at the San Carlos and Half Moon Bay Airports between the hours of 11 p.m. and 6 a.m. as described and depicted in Appendices 1 and 2 to the County Airport Parking Policy.
- 3. The establishment of "Overnight Parking" zones at the San Carlos and Half Moon Bay Airports for use with a valid permit for a maximum period of seven (7) consecutive days without the written permission of the Airport Manager as described and depicted in the County Airport Parking Policy.
- 4. The Director of Public Works, or his designee, to issue administrative penalties and/or citations for violations of the County's parking ordinance as allowed by the County Ordinance Code.
