## THE BOARD OF SUPERVISORS COUNTY OF SAN MATEO, STATE OF CALIFORNIA RESOLUTION HONORING AND COMMENDING

## ADRIENNE J. TISSIER

2015 Women in County Government Distinguished Honoree

WHEREAS, ADRIENNE J. TISSIER serves as Supervisor for the Fifth Supervisorial District on the Board, representing Daly City, Brisbane, Colma, and parts of South San Francisco and San Bruno; and is currently serving her third term having been elected to the Board in November of 2004 and, twice serving as President of the Board of Supervisors in 2008 and 2012; and

WHEREAS, throughout her career on the Board, ADRIENNE J. TISSIER has focused on investing in and improving public safety, public health, transportation and growing our economy; and, she has been a strong voice for her constituents and all San Mateo County residents on regional boards and commission including her appointment to the Local Agency Formation Commission; and

WHEREAS, in her commitment to public safety, ADRIENNE J. TISSIER in 2005 created Disaster Preparedness Day in partnership with the San Mateo County Office of Emergency Services; in 2013 partnered with Congresswoman Jackie Speier in a convening on preventative youth behavioral health issues in response to the Sandy Hook school shootings; and, working with the California Highway Patrol to develop the Age Well-Drive Smart Program promoting senior driving safety; and

WHEREAS, ADRIENNE J. TISSIER represents the Board of Supervisors on the nine-county Metropolitan Transportation Commission, having served two terms as Chair; serves on the Board of Directors for the San Mateo County Transit District (SamTrans), including deep involvement in creating the SamTrans' Senior Mobility Plan; as well as sitting on the Peninsula Corridor Joint Powers Board (Caltrain), working tirelessly towards Caltrain electrification; and

**WHEREAS**, in addressing comprehensive and responsible public health services, ADRIENNE J. TISSIER sits on the San Mateo Medical Center Board of Directors and serves on the Community Health Reform Advocacy Committee; and, in 2006, working with 14 municipal police departments and the Sheriff's office, created the nation's first-ever, permanent program for the proper disposal of household pharmaceuticals, including those classified as controlled substances.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of San Mateo, State of California, hereby commends ADRIENNE J. TISSIER for her exemplary leadership and commitment to the community in San Mateo County and extends heartfelt congratulations for being named the recipient of the Women in County Government 2015 Distinguished Honoree award.
