DR. JOSEFINA ENRIQUEZ

2012 DOLORES MULLIN 'LIKE A ROCK' AWARD

WHEREAS, DR. JOSEFINA ENRIQUEZ *was born and educated in the Philippines, receiving her medical degree from the University of Santo Tomas, Faculty of Medicine, moving to the United States in 1965; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *received her Internal Medicine training at Jersey Shore Medicine Center and at the United States Public Health Hospital, moving to Half Moon Bay in 1967 opening her practice on Main Street in 1983; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *has been active in the Half Moon Bay community since the day she opened her practice, becoming the first woman member of the Rotary Club of Half Moon Bay in 1986; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *was instrumental in founding the Coastside RotaCare free clinic through her involvement with the Rotary Club; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *donates time to the Coalition of Concerned Medical Professionals which provides health care free of charge to low-income workers and their families; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *was inducted into the San Mateo County Women's Hall of Fame in 2001 and in 2010 was honored as the 19th Assembly District's Woman of the Year by Assemblyman Jerry Hill as well as the 2011 Distinguished Service Award from the San Mateo County Medical Association; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *is tackling a new project which involves building a shelter for local homeless veterans and people evicted from their homes; and*

WHEREAS, DR. JOSEFINA ENRIQUEZ *is a single mother who raised her two sons Andrew and Alex and is now the proud grandmother of three granddaughters; and*

NOW, THEREFORE, BE IT RESOLVED *that the Board of Supervisors of San Mateo County does hereby recognize and congratulate DR.
