Subject: Revenue Agreement from InnVision Shelter Network

RECOMMENDATION:

Adopt a Resolution authorizing a Revenue Agreement from InnVision Shelter Network to the County of San Mateo Vocational Rehabilitation Services Catering Connection to provide healthy dinner meals to families in transitional housing and weekly cooking demonstrations, commencing on January 29, 2013 and ongoing until canceled by either party. The revenue to the County in the first three years is anticipated to be \$329,184.

BACKGROUND:

InnVision Shelter Network contacted Vocational Rehabilitation Services (VRS) Catering Connection in June 2008, requesting dinner meals for families in transitional housing. After meeting with Shelter Network, a core issue was identified and discussed in regards to the families in the transitional shelter lacking knowledge of nutrition and how to prepare healthy meals. VRS Catering Connection will provide weekly healthy cooking demonstrations to families in addition to the daily dinner meals. The two components (daily dinner meals and weekly healthy cooking demonstrations) will increase the basic knowledge and understanding of nutrition as well as provide healthy meals on a daily basis; therefore ensuring and increasing the basic health of San Mateo County families in need.

DISCUSSION:

The County is the Contractor for this Agreement and will be providing 60 dinner meals 360 days per year and weekly cooking demonstrations for families at InnVision Shelter Network. By providing nutritious meals and weekly healthy cooking demonstrations, VRS Catering Connection will be providing knowledge/skills for families in transition toward learning the importance of eating healthy, well-rounded meals as well as how to prepare nutritious meals for their families.

County Counsel has reviewed and approved the Agreement and Resolution as to form. Acceptance of this Agreement contributes to the Shared Vision 2025 outcome of a Prosperous Community by providing 21,600 residents with nutritious meals each year. It is also anticipated that 208-520 residents will obtain the knowledge/skills to prepare healthy meal for their families.

The term of this revenue Agreement commences on January 29, 2013, and is ongoing until canceled by either party. The total obligation to the County for the first three years of this Agreement is anticipated to be \$329,184. The revenue is included in the FY 2012-13 Adopted Budget. Future year revenue will be included in future year Recommended Budgets. There is no Net County Cost.
