Subject: Agreement with Taborda Solutions, Inc.

### **RECOMMENDATION:**

Adopt a Resolution authorizing an agreement with Taborda Solutions, Inc. for a Cyber Security Automated Threat Information Exchange system for the Northern California Regional Intelligence Center for the term January 1, 2015 through January 31, 2018, in an amount not to exceed \$887,641.

# BACKGROUND:

On November 19, 2013, your Board approved an agreement with the City and County of San Francisco for the distribution of FY 2013 Urban Area Security Initiative (UASI) grant funds to support the Northern California Regional Intelligence Center (NCRIC) for a term commencing November 1, 2013 through February 28, 2015, in the amount of \$4,080,378.

On September 9, 2014, your Board approved the first amendment to the agreement between the City and County of San Francisco and the County of San Mateo for the distribution of FY 2013 UASI grant funds, extending the term through March 31, 2015, and increasing the amount by \$1,012,873 to \$5,093,251 for the purchase of a Cyber Security Automated Threat Information Exchange (ATIX) system.

# DISCUSSION:

All California organizations are challenged with defending their network devices against persistent, mature, and sophisticated malicious cyber threat actors that seek to exfiltrate secure information, destroy resources or potentially cause physical harm. Law enforcement agencies do not possess the resources to regularly monitor networks, harden defenses, identify compromise or respond to incidents in a timely and effective manner. To help alleviate these challenges, the NCRIC released Request for Proposals (RFP) No. 2014-1297 for a Cyber Security ATIX system. The RFP requested for the

proposer to provide cyber security hardware, software, and services to deliver a collection, analysis, and dissemination platform for perimeter network activity. The NCRIC received five vendor proposals and Taborda Solutions, Inc. was the selected vendor.

The Sheriff's Office is requesting this Board to accept the agreement with Taborda Solutions, Inc. for the NCRIC's Cyber Security ATIX system for a term commencing January 1, 2015 through January 31, 2018, in an amount not to exceed \$887,641.

The Sheriff's Office is also requesting this Board to authorize the Sheriff or Sheriff's designee to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.

The Contractor has assured compliance with the County's Contractor Employee Jury Service Ordinance, as well as all other contract provisions that are required by County ordinance and administrative memoranda, including but not limited to insurance, hold harmless, nondiscrimination and equal benefits.

County Counsel has reviewed and approved the Resolution and agreement as to form.

Approval of the agreement contributes to the Shared Vision 2025 outcome of a Collaborative Community as the NCRIC is a collaborative regional public safety undertaking, which leads to safer communities by improving cooperation and information sharing between agencies.

The agreement is for a term commencing January 1, 2015 through January 31, 2018, and for an amount not to exceed \$887,641. All costs associated with the NCRIC operation are 100% reimbursable from federal and state funds. There will be no Net County Cost incurred.
