RESOLUTION AUTHORIZING THE BOARD TO REDEFINE LOCAL WORKFORCE INVESTMENT AREA BOUNDARIES AND TO CREATE A NEW LOCAL WORKFORCE BY JOINING WITH THE EXISTING NORTH VALLEY (NOVA) CONSORTIUM AND EXECUTE NECESSARY SUPPORTING DOCUMENTS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board is being asked to redefine local Workforce Investment Area boundaries and create a new local workforce area by joining with the existing North Valley (NOVA) consortium; and

WHEREAS, this Board acknowledges that the County of San Mateo and the Northern Silicon Valley share jobseekers, industries, and a regional labor market where technology, professional, scientific, and technical sectors will continue to lead the economic base of both areas.

WHEREAS, this Board acknowledges the intent of the Workforce Innovation and Opportunity Act to provide workforce development services based on regional labor market needs

WHEREAS, this County of San Mateo Workforce Investment Board has voted and recommends to this Board to redefine local Workforce Investment Area boundaries by joining with the existing NOVA consortium; and

WHEREAS, The County of San Mateo workforce development programs will be

administered by the City of Sunnyvale-NOVA, designated as the local operator, by the Joint Powers Agency composed of the cities of Cupertino, Los Altos, Milpitas, Mountain View, Palo Alto, Santa Clara and Sunnyvale; and

WHEREAS, San Mateo County Manager and the will recommend the following: (1) that the NOVA Workforce Investment Board as defined by the Workforce Innovation and Opportunities Act create a subcommittee to monitor and oversee the delivery of services in San Mateo County; and (2) that the NOVA Workforce Investment Board consider San Mateo County representatives for any vacant positions on the Board.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that

- A. This Board of Supervisors moves to redefine local Workforce
 Investment Area boundaries and create a new local workforce area by
 joining with the existing North Valley (NOVA) consortium.
- B. The President of this Board of Supervisors is hereby authorized and directed to sign documents notifying the NOVA Joint Powers Agency of the Board's request to be included into the NOVA Consortium on behalf of the County of San Mateo; and the Clerk of this Board shall attest the President's signature thereto;
- C. The President of this Board of Supervisors is hereby authorized and directed to sign documents notifying the California Workforce Investment

Board and the Employment Development Department of the Board's request to be included into the NOVA Consortium on behalf of the County of San Mateo; and the Clerk of this Board shall attest the President's signature thereto;

D. The President of this Board of Supervisors is hereby authorized and directed to sign documents petitioning the Governor of the State of California to redefine the existing NOVA workforce investment area to include the County of San Mateo as a member and location within the boundaries of this consortium of jurisdictions. This Board's intent is to request to be included into the NOVA Consortium on behalf of the County of San Mateo; and the Clerk of this Board shall attest the President's signature thereto.
