RESOLUTION: (A) ACCEPTING THE COMMUNITY SERVICES BLOCK GRANT NUMBER 15F-2040 FUNDING FROM THE STATE DEPARTMENT OF COMMUNITY SERVICES AND DEVELOPMENT FOR THE PURPOSE OF HELPING HOMELESS FAMILIES AND INDIVIDUALS AT RISK OF HOMELESSNESS TO REMAIN HOUSED, FOR THE TERM OF JANUARY 1, 2015 THROUGH DECEMBER 31,2015 IN THE AMOUNT OF \$113,863; AND (B) AUTHORIZING THE DIRECTOR OF THE HUMAN SERVICES AGENCY OR THE DIRECTOR'S DESIGNEE TO EXECUTE CONTRACT AMENDMENTS FROM THE STATE DEPARTMENT OF COMMUNITY SERVICES AND DEVELOPMENT TO ACCEPT THE TERMS AND ADDITIONAL FUNDING IN AN AMOUNT UP TO \$421,485

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Community Services Block Grant (CSBG) funds are administered by the State Department of Community Services and Development (CSD) and are intended to advance methods of reducing poverty and revitalizing low-income communities; and

WHEREAS, the CSD has awarded the County of San Mateo Human Services

Agency funding in the amount of \$113,863 through the execution of Revenue

Agreement Number 15F-2040, for the term of January 1, 2015 through December 31,

2015; and

WHEREAS, it has been requested that your Board authorize the Director of the Human Services Agency or the Director's designee to execute the Amendment(s) to Revenue Agreement Number 15F-2040, from CSD, to accept funding in an amount up to \$421,485 when issued; and

WHEREAS, the Board has been presented with such Revenue Agreement and

said Board has examined and approved same as to both form and content and desires to enter into the same.

## NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that

- A. The President of the Board of Supervisors be, and is hereby authorized and directed to execute said Revenue Agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto; and;
- B. The Director of the Human Services Agency or the Director's designee shall be authorized to execute subsequent Amendment(s) to said Revenue Agreement for additional funding in an amount up to \$421,485.
