**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH TRIMBLE NAVIGATION LIMITED, SUCCESSOR IN INTEREST TO MANHATTAN SOFTWARE INC., TO CONTINUE PROVIDING TECHNICAL SUPPORT FOR THE INTEGRATED WORKPLACE MANAGEMENT SYSTEM, EXTENDING THE TERM THROUGH FEBRUARY 9, 2016, INCREASING THE AMOUNT BY \$45,825 TO AN AMOUNT NOT TO EXCEED \$145,350**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, in May 2010, following the recommendation of the County's Workplace Standards Committee, the County entered into an agreement with Manhattan Software for CenterStone, a Facility Management Application, also known as an Integrated Workplace Management System (IWMS); and

**WHEREAS**, the County drafted a Facility Master Plan in order to maintain an updated inventory of real property assets leased or held by the County, document work locations for employees for crisis communications, create a central location for information about all County-owned or leased properties, create cost savings through efficiencies in space reduction due to more strategic space planning and introduce new workspace standards (and sustainability goals); and

**WHEREAS**, on May 24, 2011, your Board adopted Resolution 071393, accepting the County's Facility Master Plan, which recommends the purchase and use of an Integrated Workplace Management System (IWMS); and

**WHEREAS**, in, 2013, the Department of Public Works entered into a renewal agreement with Manhattan Software for CenterStone Software-as-a-Service (SaaS). The contract included the option for a one-year extension; and

**WHEREAS**, in April 2014 the Director of Public Works approved an amendment to the agreement for \$7,875, to provide automated integration of Human Resources data into the CenterStone system, thus increasing the contract amount to \$99,525; and

**WHEREAS**, it is necessary for the Department to extend the term of services being provided in order to fully implement the system; and

**WHEREAS**, this Board has been presented with the Amendment and has examined and approved it as to both form and content and desires to enter into the Amendment.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and is hereby authorized and directed to execute said Amendment for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.
