WHEREAS, for the past two decades, Officer Jeffery Rodriguez has demonstrated exemplary service to the residents of Daly City as an officer with the Daly City Police Department; and

WHEREAS, Officer Jeffery Rodriguez was appointed a Daly City police officer on August 19, 1996 following five years of service with the Broadmoor Police Department where he served as a reserve Sergeant and having previously graduated from El Camino High School in South San Francisco and having attended classes at the College of San Mateo in San Mateo and later graduated from the Police Academy at Los Medanos College in Contra Costa County; and

WHEREAS, Officer Jeffery Rodriguez began his distinguished career with the Daly City Police Department as a Patrol Officer serving all shifts. Officer Jeffery Rodriguez was later promoted to a variety of units including the Traffic Division as a motorcycle officer enforcing traffic safety, the Daly City SWAT Team for over 10 years, served as the Police Office Association's President for over 10 years and retired as Senior Motor Officer within the Traffic Division; and

WHEREAS, Officer Jeffery Rodriguez, having earned the respect of the Daly City community and the esteem of his peers, has been responsible for training many of Daly City's officers including his work as a Field Training Officer in the Patrol Division, a Motorcycle Instructor, a Driver's training instructor, and instructor of automobile accident investigation and other courses related to traffic safety; and

WHEREAS, Officer Jeffery Rodriguez's outstanding performance has been recognized with over 110 Department and Unit Citations, Letters of Appreciation and Letters of Compliment, and recognition from outside agencies including being the recipient of the Medal of Valor for a shooting involving an armed suspect; and

WHEREAS, Officer Jeffery Rodriguez has made significant contributions to the safety and well-being of the residents of Daly City and the entire San Mateo County community.
