Lieutenant Louie T. Pezzola

Upon his retirement from the
Daly City Police Department

WHEREAS, for the past 25 years, Lieutenant Louie T. Pezzola has demonstrated exemplary service to the residents of Daly City as a Lieutenant with the Daly City Police Department; and

WHEREAS, Lieutenant Louie T. Pezzola was appointed a police officer on January 2, 1998 after graduating from Jefferson High School in Daly City in 1981 and having attended and graduated from the Basic Police Academy at College of the Redwoods; and

WHEREAS, Lieutenant Louie T. Pezzola began a distinguished two and a half decades long career with the Daly City Police Department as a Patrol Officer serving all shifts. Lieutenant Louie T. Pezzola was later promoted to a variety of units including the SWAT Team, the Traffic Division the Detective Division and in 1996 he received the training and was appointed a Background Investigator; and

WHEREAS, Lieutenant Louie T. Pezzola, having earned the respect of the Daly City community and the esteem of his peers, was promoted to the notable and supervisory role of Lieutenant on December 9, 2006 after serving as Sergeant since November 13, 1999; and

WHEREAS, Lieutenant Louie T. Pezzola's outstanding performance has been recognized with over 130 Department and Unit Citations, Letters of Appreciation and Letters of Compliment, including being voted Most Valuable Police Officer in 1992 and again in 1998 and having been honored by the Veterans of Foreign Wars of the United States for his work with the community; and

WHEREAS, Lieutenant Louie T. Pezzola played a key role in securing over a half a million dollars in grants for DUI enforcement and traffic safety which led to the purchase of a DUI Command Bus as well as his role in implementing Daly City's new Records Information Management System (RIMS); and

WHEREAS, Lieutenant Louie T. Pezzola has made significant contributions to the safety and well-being of the residents of Daly City and the entire San Mateo County community.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of San Mateo County congratulates and commends Lieutenant Louie T. Pezzola upon his retirement from the Daly City Police Department.
