RESOLUTION AUTHORIZING THE SHERIFF OR SHERIFF'S DESIGNEE TO EXECUTE AN AGREEMENT WITH KAMRAN AND COMPANY, INC. FOR THE PURCHASE AND INSTALLATION OF FOOD SERVICE EQUIPMENT FOR THE MAPLE STREET CORRECTIONAL CENTER IN AN AMOUNT NOT TO EXCEED \$458,878 AND A TERM COMMENCING SEPTEMBER 1, 2015 TO FEBRUARY 29, 2016

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in December 2010, the Board of Supervisors acquired 4.85 acres of land in Redwood City east of Highway 101 for the purpose of constructing a replacement jail and the Board approved a mitigated negative declaration for the replacement jail on that site; and

WHEREAS, in October 2011, the Board approved a jail project at the site and authorized the Sheriff to proceed with a replacement jail; and

WHEREAS, on November 5, 2013, the Board approved a contract with Sundt Layton, a Joint Venture, to construct the Maple Street Correctional Center (MSCC); and

WHEREAS, the construction of MSCC is anticipated to be complete by the end of 2015; and

WHEREAS, a substantial amount of equipment identified as Furniture, Fixtures and Equipment (FF&E) must be ordered, delivered, and installed in a timely manner in

order to operate the facility; and

WHEREAS, MSCC has been designed and is being constructed to include a very large kitchen capable of preparing three (3) meals per day for every inmate housed in San Mateo County correctional facilities; and

WHEREAS, the preparation of such large quantities of meals requires an investment in commercial grade food service equipment that must be well constructed, reliable, and durable and yet be safe and secure for inmates and staff; and

WHEREAS, in July 2015, the Sheriff's Office, utilizing the service Public Purchase, issued an Invitation to Bid (ITB) for the purchase and installation of commercial grade food service equipment for MSCC; and

WHEREAS, a selection committee comprised of members of the Sheriff's Office

Jail Planning Bureau, Architect HOK, and the San Mateo County Purchasing

Department reviewed and carefully evaluated the bid submitted in response to the ITB;

and

WHEREAS, said selection committee is recommending to award the contract to Kamran and Company, Inc. as the lowest responsible bid received for the purchase and installation of the required food service equipment;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors authorizes the Sheriff or Sheriff's designee to execute an

agreement with Kamran and Company, Inc. to provide and install food service equipment for the Maple Street Correctional Center (MSCC) in an amount not to exceed \$458,878 and a term commencing September 1, 2015 to February 29, 2016.
