RESOLUTION CONGRATULATING THE

San Mateo County Sheriff's Office On the Grand Opening of The Maple Street Correctional Center

WHEREAS, The San Mateo County Jail Overcrowding Task Force (JOTF) was formed in 2004 and was comprised of members of the Board of Supervisors, Sheriff's Office, District Attorney, Probation, County Manager, Courts, Private Defender, Service League, Police Chiefs Association and Health System, and was reconstituted as the Criminal Justice Committee after agreement was reached that the Women's Correctional Center was in need of replacement; and

WHEREAS, the firm of DMJM Design/AECOM was selected to conduct the needs assessment for the new facility and in 2008, after including an analysis of the Maguire Correctional Facility, recommended construction of 1579 new inmate beds to meet the 2026 planning horizon; and

WHEREAS, Liebert and Associates was retained in January 2009 to assist the Sheriff's Jail Planning Unit in the site selection process and in preparing a pre-architectural plan for the replacement jail; and

WHEREAS, the Jail Planning Advisory Committee was formed and after extensive outreach to the community the site known as Chemical Way which consists of approximately 4.7 acres located off of Maple Street and east of Highway 101 in Redwood City was selected for the new facility; and

WHEREAS, HOK was selected as the architectural firm to design the new facility and Sundt Layton, a joint venture, was retained as the contractor on the project; and

WHEREAS, The Maple Street Corrections Center will follow the Sheriff's Office ASPIRE Model: "Access to Services and Programs to Inspire Reentry and Empowerment" which refers to the Sheriff's Office commitment to providing an enhanced continuum of care within its correctional facilities, including service needs assessment, individual case management, targeted programming and reentry preparation. The new facility will offer extensive programming including GED Study, alcohol and drug rehabilitation services, exercise, religious, cognitive and vocational services, and will make a significant contribution to the safety, health and
