## Marina Fraser

**WHEREAS, Marina Fraser** was born to Thomas and Marina Fraser in Yonkers, New York, and in 1966 moved to Daly City from New York, with her parents and brother; and

**WHEREAS, Marina Fraser** and family moved to the Coastside in 1972, where she went to and graduated from Half Moon Bay High School, and while in High School was in FFA, where she raised a lamb, Lamb Chops, and a steer, Herbie, for the San Mateo County Fair; and

WHEREAS, Marina Fraser went on to San Jose State and worked at several different companies before she went to work for Genentech and became a trainer and project manager; and

**WHEREAS, Marina Fraser** was appointed to the Half Moon Bay Park and Recreation Commission, serving from 1998 to 2002, and was elected to the Half Moon Bay City Council in 2003, and is currently still serving on the Council, having been Mayor three different times; and

WHEREAS, Marina Fraser served as President and Vice President for the Sewer Authority Mid Coast, SAM, and served as Chairman and Vice Chairman on the San Mateo County Council of Cities, and has served as a member of the San Mateo County Joint Powers Authority, the San Mateo County Congestion Relief Alliance, the San Mateo City/County Association of Government-CCAB, and with the San Mateo County Emergency Operations Center; and

WHEREAS, Marina Fraser, along with fellow Councilman John Muller, went to Washington DC to obtain funding for the Emergency Operation Center in Half Moon Bay; and

WHEREAS, Marina Fraser obtained funding and purchased the bike racks for Main Street, Half Moon Bay, and collaborated with Federal, State and County agencies to get funding to replace the Pillarcitos Bridge; and

WHEREAS, Marina Fraser collaborated with the City of Half Moon Bay, County of San Mateo and a private landowner to get Half Moon Bay – Smith Field, and the ability to build a Senior Complex on Main Street in Half Moon Bay; and

**WHEREAS, Marina Fraser** was instrumental in the reorganization and restructuring of the City of Half Moon Bay's government to gain fiscal stability after a devastating lawsuit; and

**WHEREAS, Marina Fraser** was active with the Half Moon Bay Spanishtown Historical Society, a member of Friends of the Library and the Cougar Boosters; and

WHEREAS, Marina Fraser is loved and admired by her family, friends and so many people on the coast for her devotion and commitment to making their community better a better place to live in.
