RESOLUTION AUTHORIZING AN AGREEMENT WITH QUINCY ENGINEERING, INC. FOR A CAUSEWAY FEASIBILITY STUDY, FOR THE TERM OF JUNE 28, 2016 THROUGH JUNE 27, 2019 IN AN AMOUNT NOT TO EXCEED \$512,656

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, In 2013 the San Mateo County Resource Conservation District (RCD) issued a Request for Proposals (RFP) to identify solutions to the flooding on Pescadero Creek Road from Butano Creek. Cbec eco-engineering, Inc. (cbec) and Stillwater Sciences were selected to identify and evaluate alternatives for addressing road flooding that occurs during storm events and to also maximize opportunities for ecosystem restoration. Construction of a causeway was identified as a potential long-term solution to the flooding on Pescadero Creek Road; and

WHEREAS, the Department of Public Works (Department) conducted a Request for Proposal (RFP) process for consultant services to develop a feasibility study for constructing a causeway along Pescadero Creek Road spanning Butano Creek (Project). Proposals were solicited from engineering firms with the expertise needed for this Project by e-mail, through advertising in a local newspaper, and by posting information to the Department's website. An evaluation committee comprised of Department staff, a District 3 Board of Supervisors aide, a member of the San Mateo County Resource Conservation District (RCD), and a member of the Pescadero

Municipal Advisory Council (PMAC) conducted a review of the proposals submitted by two (2) firms and participated in interviews, with each of the firms. Based on the results of the proposals review and interviews, the Department is recommending that Quincy Engineering, Inc. be retained; and

WHEREAS, it is anticipated that the consultant's work will take one to two years and will include at a minimum, field surveys, geotechnical investigation, hydraulic assessment, environmental studies, community engagement, conceptual design, and preparation of causeway feasibility study; and

WHEREAS, the Board of Supervisors of the County of San Mateo is authorized to engage the services of professional technical experts; and

WHEREAS, the Department is interested in executing an agreement for the development of the Causeway Feasibility Study for a period between June 28, 2016 through June 27, 2019 in an amount not to exceed \$512,656; and

WHEREAS, Quincy Engineering, Inc. has a consultant team with the expertise required for this Project, which includes, but is not limited to: bridge design, public outreach, environmental studies, hydraulics and hydrology engineering, and survey; and

WHEREAS, the Director of Public Works has recommended that said agreement be entered into with Quincy Engineering, Inc. for the Causeway Feasibility Study; and

WHEREAS, this Board has considered the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors shall be, and is hereby authorized and directed to execute an agreement with Quincy Engineering, Inc. for the Causeway Feasibility Study on behalf of the County of San Mateo, for the term of June 28, 2016 through June 27, 2019 in an amount not to exceed \$512,656, and the Clerk of the Board shall attest to the President's signature thereto.
