Subject: Amendment to the Agreement with the San Mateo Community Health

Authority dba the Health Plan of San Mateo to Provide Health Benefits to Independent Providers of the In-Home Supportive Services Program

RECOMMENDATION:

Acting as the Governing Board of the Public Authority, adopt a resolution authorizing an amendment to the agreement with the San Mateo Community Health Authority, dba the Health Plan of San Mateo, to provide health benefits to independent providers of the In-Home Supportive Services program to extend the term to December 31, 2017 and to add \$4,500,000 for a total contract amount not to exceed \$7,500,000.

BACKGROUND:

In 1993, your Board approved an Ordinance establishing a separate legal entity, the Public Authority of the County of San Mateo (PA), to administer the individual provider components for the In-Home Supportive Services (IHSS) program and designated the San Mateo County Board of Supervisors as the PA's Governing Board (Board). The IHSS program's mission is to assist eligible aged, blind, and disabled individuals with remaining in their own homes as long as safely possible. The program uses independent providers to assist residents with a wide variety of daily living activities such as bathing, feeding, meal preparation, and certain paramedical services authorized by a physician.

In 2000, 2013, and 2015, your Board adopted Memoranda of Understanding with Service Employees International Union, Local 521, under which the PA administers salaries and benefits, including health benefits, for independent providers.

In 2001, your Board, as the PA's Governing Board, approved an agreement with HPSM to provide health benefits through the HealthWorx plan for independent providers.

In November 2012, your Board authorized an agreement with a monthly HealthWorx premium of \$303, in an amount not to exceed \$9,134,934. In July 2015, your Board authorized a subsequent agreement for the term July 1, 2015 through June 30, 2016, with HPSM to provide health benefits for independent providers in an amount not to exceed \$3,000,000.

DISCUSSION:

As part of the pilot Coordinated Care Initiative, the IHHS Statewide Authority officially assumed collective bargaining responsibility for San Mateo's IHSS providers on February 23, 2015. The IHSS Statewide Authority has requested that the PA extend its health benefits contract through HealthWorx for an additional eighteen months in order to prevent a lapse in benefit coverage for IHSS providers.

This amendment to the agreement adds \$4,500,000 to allow the PA to continue providing health insurance coverage to independent providers via HPSM through December 31, 2017. The current IHSS premium for health benefits is \$242.50 per member, per month for the term August 1, 2016 through December 31, 2017.

The resolution contains the County's standard provisions allowing amendment of the fiscal obligations by maximum of \$25,000 (in aggregate).

The amendment and resolution have been reviewed and approved by County Counsel as to form.

This amendment contributes to the Shared Vision 2025 outcome of a Healthy Community by allowing independent providers to stay healthy and continue their employment as caregivers to at-risk individuals. It is anticipated that 100% of eligible IHSS home care providers who apply for health benefits will be enrolled.

FISCAL IMPACT:

The term of the amended agreement is July 1, 2015 through December 30, 2017. The amount of the amended agreement is an increase of \$4,500,000 for the eighteen-month term, for a new not to exceed amount of \$7,500,000. The County pays a fixed annual "Maintenance of Effort" amount for the provision of IHSS and Public Authority services, and the full amount of this agreement will be paid for through federal (50%) and state (50%) reimbursement. The payment provisions and levels of service in this contract are essentially the same as the prior contract. Funds for these services are included in the PA FY 2016-17 Recommended Budget and will be included in the FY2017-18 Recommended Budget.
