

**AMENDMENT TO THE GROUP AGREEMENT

WHEREAS, on July 26, 2011, by Resolution 71547 the parties entered into a Group Agreement for the provision of health care benefits to independent providers of the In-Home Supportive Services program who are subscribed and enrolled under HealthWorx, through the Authority, hereafter defined as "Covered Services"; and

WHEREAS, the parties wish to amend the Group Agreement to increase the premium from \$195.31 per member/per month to \$303.00 per member/per month.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. The Original Cover Page is deleted and replaced and incorporated herein as the revised cover page as attached; and
2. The Original Table of Contents is deleted and replaced and incorporated herein as the revised Table of Contents as attached and;
3. Original Attachment B is deleted and replaced and incorporated herein as Attachment B – Amendment One as attached.
4. **All other terms and conditions of the Agreement dated July 26, 2011, between the Plan and Authority shall remain in full force and effect.**

The PLAN is subject to the requirements of state and federal laws governing health care plans, including the Knox-Keene Act of 1975 and its amendments. Any provisions required to be in this Agreement by either the applicable Statute or Regulations will bind PLAN whether or not expressly stated in this Agreement.

If any provision of this Agreement is deemed to be invalid or illegal, such provision shall be fully severable and the remaining provisions of this Agreement shall continue in full force and effect.

This Agreement and its attachments have the same meaning given those terms in the EOC.
