Subject: Agreement with Total Renal Care, Inc.

RECOMMENDATION:

Adopt a Resolution authorizing an agreement with Total Renal Care, Inc. to provide acute inpatient dialysis services at the San Mateo Medical Center for the term of December 1, 2012 through November 30, 2015, in an amount not to exceed \$1,500,000.

BACKGROUND:

San Mateo County is responsible for providing medical care to its medically indigent adult population, including acute inpatient dialysis treatment at San Mateo Medical Center (SMMC). Because of the costs associated with necessary equipment and the need for specialized staffing, it is more economical to contract for this service with a third-party vendor than to perform the services through SMMC.

DISCUSSION:

Total Renal Care, Inc. (Total Renal Care) has been providing SMMC with high quality dialysis care since 1999 and maintains compliance with regulatory standards. SMMC recently completed a Request for Proposals (RFP) for acute care dialysis services. Total Renal Care was elevated because of the range of offered services and its demonstrated program competency. In addition, Total Renal Care provides acute dialysis services (including equipment, supplies, appropriate personnel and in-service training) and has adequate capacity for staffing, and other key factors required to meet SMMC's renal care service needs. The agreement has been delayed due to extensive negotiations with the vendor.

County Counsel has reviewed and approved the agreement and Resolution as to form. Contractor meets insurance certification requirements.

SMMC also requests that your Board authorize the Chief of the Health System or designee to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.

The Contractor has assured compliance with the County's Contractor Employee Jury Service Ordinance, as well as all other contract provisions that are required by County ordinance and administrative memoranda, including but not limited to insurance, hold harmless, non-discrimination and equal benefits.

This agreement contributes to the Shared Vision 2025 outcome of a Healthy Community by providing quality renal care services to San Mateo County patients. Analysis of patient clinical data is an indicator of the effectiveness of dialysis treatment. It is anticipated that the quarterly list of clinical quality indicators will be at 95% or greater.

FISCAL IMPACT:

The term of the agreement is December 1, 2012 through November 30, 2015, in an amount not to exceed \$1,500,000. Funds in the amount of \$291,670 are included in the SMMC FY 2012-13 Adopted Budget and funds in the amount of \$500,000 are included in the SMMC 2013-14 Recommended Budget. Similar arrangements will be made for future years.

The payment provisions and levels of service in this agreement for inpatient dialysis services are essentially the same as the prior agreement.

Expenses at SMMC are covered by fees for services or third-party payors whenever possible. The portion of expenses for services provided to the medically indigent or to those covered by programs that do not meet the full costs of care are covered by the County's General Fund contribution to SMMC, and are within the existing annual appropriation.
