**For Twelve Years Of Service To The Burlingame Community**

**WHEREAS**, CATHY BAYLOCK was elected to the Burlingame City Council in 2001, was reelected in 2005 and 2009, and served as Mayor in 2006 and 2010, and has made outstanding contributions to the community by working to protect Burlingame's historic landmarks, magnificent trees, architectural heritage, unique neighborhoods and the integrity of its parks; and

**WHEREAS**, CATHY BAYLOCK holds a Bachelor's degree in Business Administration from Sacred Heart University in Fairfield, Connecticut; is the past Bank Manager and Assistant Vice President of Bay View Bank in Burlingame, and served previously as a Director of the Burlingame Chamber of Commerce Board, and has been a longtime resident of the Peninsula, residing with her husband Joe and sons AJ and Nick in Burlingame for over twenty years, now living in a circa 1910 Arts and Crafts bungalow; and

**WHEREAS**, CATHY BAYLOCK has been an active member of the community, having served as a Teen Facilities Committee member, Chair of the Washington School Site Council, Financial Secretary for the Washington School P.T.A., Chair of Burlingame's Centennial Committee and Treasurer and Board member at St. Paul's Nursery School, and has served as Treasurer of the Burlingame Historical Society since 2000 and oversaw the publishing of the book "Burlingame Centennial 1908-2008", which has sold 1800 copies, and helped open the Burlingame History Museum in the Burlingame Train Depot in September 2008; and

**WHEREAS**, CATHY BAYLOCK's Council duties include overseeing the Park and Recreation budget, serving as a member of the Economic Development Committee, acting as a liaison to the Burlingame Elementary Schools Committee and Burlingame Chamber of Commerce, serving as a member of the Bicycle and Pedestrian Advisory Committee for C/CAG and the Community Center Master Plan Advisory Committee and also serving as the City's delegate to the Association of Bay Area Governments, the Peninsula Cities Consortium on High Speed Rail and the San Mateo County Rail Corridor Partnership, and serving six years as a member of the Central County Fire Joint Powers Authority including two years as its chair
