RESOLUTION ESTABLISHING PUBLIC HEALTH CLINICS FEES EFFECTIVE

MAY 1, 2013

**WHEREAS,** the Board of Supervisors of the County of San Mateo, State of California, has authority to establish and change certain fees or service charges subject to legal requirements; and

WHEREAS, Section 101325 of the Health and Safety Code authorizes the County to charge fees to pay the reasonable expenses of the Health Officer in enforcing state laws, regulations and orders relating to public health; and

WHEREAS, the Board has determined to exercise this authority by adopting the fees that are set forth in Exhibit A, attached hereto and incorporated herein by this reference as the San Mateo County Public Health Clinics Fees Schedule; and

**WHEREAS**, the Board of Supervisors finds that the fees set forth in Exhibit A do not exceed the cost of providing the product or service or enforcing the regulation for which the fees are levied.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED by the Board of Supervisors of the County of San Mateo that based on the above Recitals, the Board hereby adopts the San Mateo County Public Health Clinics Fees Schedule, attached hereto as Exhibit A, effective May 1, 2013.

\*Fees may be waived for any person who meets the eligibility criteria under the Federal Health Care for the Homeless Program (HCH) and/or for persons clinically determined to be at risk for transmitting an STD to others.

If vaccines are received by the County from the State for free, a vaccine administration fee of \$35 will apply. There will be no charge for the vaccine.

The County Health Officer may waive fees for any clinic services when it is in the best interest of the public's health, for example in outbreak situations, or in communicable disease investigations.
