**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH
REVOLT RECYCLING, LLC TO PROVIDE PACKAGING, LABELING, SHIPPING,
TRANSPORTING AND RECYCLING OF UNIVERSAL WASTE LAMPS AND
BATTERIES COLLECTED BY THE RETAIL TAKE-BACK PARTNER STORES,
INCREASING THE AMOUNT BY \$100,000
TO AN AMOUNT NOT TO EXCEED \$200,000**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Environmental Health operates a Household Hazardous Waste (HHW) Program that collects and safely processes HHW from County residents; and

WHEREAS, on September 4, 2015, the Purchasing Agent approved an agreement with Revolt Recycling, LLC (Revolt Recycling) to provide packaging, labeling, shipping, transporting and recycling of universal waste lamps and batteries collected by the retail take-back partner stores; and

WHEREAS, the contract with Revolt Recycling allows the HHW Program to significantly improve the Universal Waste Take-Back Program by providing direct pick-ups of the universal waste at the retail store locations, along with supplying the retailer with the necessary equipment, supplies and training of in-store staff for proper management, containment and storage of the universal wastes collected; and

WHEREAS, in the first year of the contract beginning in September 2015, the total volume of waste collected increased 178% from the prior year; and

WHEREAS, while the increase in program participation is desired, this dramatically impacted the anticipated contract costs by depleting funds far more rapidly

than expected; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance an amendment to the agreement with Revolt Recycling, increasing the maximum amount by \$100,000 to an amount not to exceed \$200,000; and

WHEREAS, both parties now wish to execute an amendment to the agreement providing direct pick-ups of the universal waste at the retailer store locations, along with supplying the retailer with the necessary equipment, supplies and even training of in-store staff for proper management, containment and storage of the universal wastes collected for a total obligation not to exceed \$200,000; and

WHEREAS, this Board has been presented with a form of the amendment to the agreement and has examined and approved it as to form and content and desires to enter into the amendment to the agreement; and

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors or the President of the Board be and is hereby authorized to execute this amendment to the agreement for and on behalf of the County of San Mateo and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of the Health system, or designee, is hereby authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term is/are within the current or revised fiscal provisions.
