RESOLUTION AUTHORIZING AN AGREEMENT WITH THE ASSOCIATION OF BAY AREA GOVERNMENTS NECESSARY TO IMPLEMENT PROGRAMS OF ENERGY UPGRADE CALIFORNIA IN SAN MATEO COUNTY IN 2015 AS A PARTICIPANT IN THE BAY AREA REGIONAL ENERGY NETWORK IN AN AMOUNT NOT TO EXCEED \$333,759.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in October 2007, the County of San Mateo adopted the Cool Counties Declaration committing the County to an 80% reduction in greenhouse gas emissions by 2050; and

WHEREAS, San Mateo County partnered with the Association of Bay Area Governments (ABAG) to implement the Bay Area Regional Energy Network (BayREN), a collaboration of all 9 counties in the San Francisco Bay Area that promotes regional energy savings programs, including a program to encourage homeowner to retrofit their homes for energy efficiency; and

WHEREAS, energy retrofits help to protect our natural resources by creating local green jobs and reducing greenhouse gas emissions by lowering energy consumption; and

WHEREAS, the California Public Utilities Commission (CPUC) has recognized the need for expanded collaboration with and participation by local governments to achieve market transformation toward energy efficiency as part of its Long Term Energy Efficiency Strategic Plan; and

WHEREAS, in its Decision for Phase I of Rulemaking 13-11-005, the CPUC authorized funding for Regional Energy Networks (RENs) to continue their existing programs in 2015; and

WHEREAS, San Mateo County has been designated as the lead regional implementer for the Single Family subprogram, and to conduct local outreach for other subprograms; and

WHEREAS, in order for San Mateo County to participate in the Bay Area Regional Energy Network, San Mateo County must execute agreements laying out the terms and conditions associated with the project funding with the Association of Bay Area Governments because that entity has agreed to distribute PG&E ratepayer funds to certain participating entities such as San Mateo County; and

WHEREAS, authorizing the President of the Board to execute the necessary agreements would ensure that the Bay Area Regional Energy Network programs are ready for implementation through the end of 2015.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board is hereby authorized and directed to execute the agreement with the Association of Bay Area Governments necessary to expedite receipt of grant funds to implement the Bay Area Regional Energy Network programs, for and on the behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.
