**Subject:** Adoption of the 2013 California Fire Code and amending the San Mateo

County Ordinance Code; Chapter 3.84 Fire Protection Regulations

### **RECOMMENDATION:**

Adoption of an Ordinance adopting the latest edition of the 2013 California Fire Code together with Appendix chapters 4, B, C, D, H, K, and I and referenced standards; making certain findings of local conditions; and repealing and replacing San Mateo County Ordinance Code Chapter 3.84 Fire Protection Regulations, previously introduced on November 19, 2013 and waiver of reading of the ordinance in its entirety.

#### **BACKGROUND:**

The California Fire Code is published every three years by order of the California Legislature. The 2013 edition incorporates, by adoption, the 2012 edition of the International Fire Code (IFC) published by the International Code Council. State law requires the adoption of the IFC by local fire agencies, as amended by the California Fire Code. Cities and fire agencies throughout the county are in the process of adopting the updated codes, which become effective in January 2014.

Changes to the San Mateo County Ordinance Code to include fire prevention regulations within the unincorporated area were first adopted in October 1979. Minimal revisions were made until 2007 when the 2007 California Fire Code was adopted and aligned with the previous San Mateo County Ordinance Code. This adoption continues that process with the newly adopted California Fire Code and continues the efforts among cities and fire agencies to adopt a uniform model code to better serve the communities in the county.

#### **DISCUSSION:**

The County provides fire protection services to the unincorporated area through an agreement with the California Department of Forestry and Fire Protection (CAL FIRE).

The County Fire Marshal, under the direction of the County Fire Chief, has worked with other local fire prevention officers, the County Planning and Building Department and the Department of Public Works to review and update the fire codes for the unincorporated area based on the State requirements, specific local conditions and the current ordinance.

Exhibit A provides a crosswalk table from the existing County Ordinance sections to applicable California Fire Code sections, as well as a summary of amendments to the County Ordinance. The majority of the changes realign existing sections. The primary substantive changes include Fire Marshal approval for installation of bridges and gates, rules over size and placement of large LP Gas tanks and protection of installed fire equipment in buildings.

The new codes will apply to projects submitted after January 1, 2014. Existing projects already underway will not be affected by these changes. Furthermore, the new ordinance will have minimal impact on residents and businesses since the ordinance changes are no more restrictive regulations than what currently exists in the County Ordinance. Copies of the 2013 California Fire Code including the 2012 International Fire Code are on file with the Clerk of the Board.

County Counsel has reviewed and approved the Ordinance as to form.

Approval of this Ordinance contributes to the 2025 Shared Vision of a Livable Community by updating the fire codes for the unincorporated area by protecting the health, safety and welfare of residents and property.

#### **FISCAL IMPACT:**

There is no fiscal impact associated with this action. Enforcement of fire protection regulations is funded through the contract with CALFIRE.
