AN ORDINANCE AMENDING ORDINANCE NUMBER 04674

The Board of Supervisors of the County of San Mateo, State of California,
ordains as follows:

SECTION 1. Part 4 of the Ordinance is amended as indicated:

ORGANIZATION 56000 – EMERGENCY MEDICAL SERVICES

1. The salary for Item D035, EMS Administrator, is changed to range 7711

ORGANIZATION 59000 – ENVIRONMENTAL HEALTH SERVICES

1. The salary for Item D128, Director of Environmental Health, is changed to range 7711

ORGANIZATION 66000 – SAN MATEO MEDICAL CENTER

1. The salary for Item D145, Dental Program Manager, is changed to range 8675.

SECTION 2. Part 14 of the Ordinance is amended as indicated:

ORGANIZATION 14000 CONTROLLERS

1. Item E368, Public Services Specialist is decreased by 1 position for a new total of 0 positions.
2. Item E337, Office Specialist is increased by 1 position for a new total of 2 positions.

ORGANIZATION 15000 TAX COLLECTOR-TREASURER

1. Item E351, Fiscal Office Services Supervisor-E is decreased by 1 position for a new total of 1 position.
2. Item E354, Banking and Cash Management Supervisor-E is increased by 1 position for a new total of 1 position.

ORGANIZATION 39000 PARKS AND RECREATION

1. Item L042, Gardener is decreased by 1 position for a new total of 0 positions.

2. Item L040S, Park Ranger Series is increased by 1 position for a new total of 28 positions.

ORGANIZATION 62400 FAMILY HEALTH

1. Item E416S, Medical Office Assistant Series is decreased by 1 position for a new total of 11 positions.
2. Item E420, Medical Office Specialist is increased by 1 position for a new total of 7 positions.

ORGANIZATION 66000 SANM MATEO MEDICAL CENTER

1. Item T060, Supervising Custodian - E is decreased by 1 position for a new total of 2 positions.
2. Item E462, Payroll/Personnel Services Supervisor is increased by 1 position for a new total of 2 positions.

ORGANIZATION 79000 HOUSING

1. Item D213, Deputy Director of Housing is decreased by 1 position for a new total of 0 positions.
2. Item D184S, Management Analyst Series is increased by 1 position for a new total of 1 position.
3. Item R010, Housing and Community Development Supervisor, is decreased by 1 position for a new total of 0 positions.
4. Item R001S, Housing and Community Development Specialist Series is increased by 1 position for a new total of 4 positions.

SECTION 3. The changes in Section 1 are effective at the start of the first pay period following adoption. The changes in Section 2, Organization 15000, Items 1 and 2 are effective retroactive to February 14, 2013. The changes in Section 2, Organization 62400, Items 1 and 2 are effective retroactive to August 1, 2013. All other changes are effective at the start of the first pay period 30 days following adoption.
