GRANT DEED

The conveyance by Grantor to Grantee pursuant to this Grant Deed is subject to: (i) a lien securing payment of real estate taxes and assessments not yet due and payable; (ii) all covenants, conditions, easements, restrictions, liens, encumbrances and other exceptions of record as of the date hereof; and (iii) the specific restrictions set forth in this Grant Deed, which restrictions shall run with the land and be binding on the parties' successors and assigns, as follows.

Rights Reserved by Grantor:

Grantee shall recognize the cooperative nature of Grantor's transfer of the Property to Grantee, and shall provide credit related to open space preservation to Grantor on signs, demonstrations, promotional materials, advertisements, publications or exhibits prepared or approved by Grantee referencing and/or situated on or near the Property, subject to the mutual agreement of Grantor and Grantee regarding text, design, and location. All such signage shall include Grantor's logo, as provided by Grantor to Grantee in connection with any and all agreements by the parties concerning signage on or near the Property.
