Subject: On-Call Fire Protection Engineering Consulting Services for Public Works

RECOMMENDATION:

Adopt a Resolution authorizing agreements with on-call Fire Protection Engineering Consulting Service firms: AON Fire Protection Engineering Corporation and Hughes Associates, Inc., to provide fire protection engineering services on various County facilities construction projects, on an as needed basis, for the term of July 1, 2014 through June 30, 2017, for an amount not to exceed \$300,000 per agreement.

BACKGROUND:

The Department of Public Works (Department) regularly maintains a number of on-call agreements with firms to provide services on as needed basis. The on-call professional service process has expedited numerous County public works projects over the years.

DISCUSSION:

The Department wishes to contract with qualified firms to provide professional Fire Protection Engineering Services. These services include consulting as necessary for a variety of projects throughout County facilities. Consultants will need to be familiar with compliance requirements under the California Office of Statewide Health Planning and Development (OSHPD), California Building Code (CBC), and the California Office of State Fire Marshal (OSFM).

The Department conducted a Request for Qualifications (RFQ) process to select fire protection engineering firms. A selection committee comprised of departmental staff reviewed and ranked the submissions received from qualified firms and made recommendations. The Department is recommending on-call agreements with two fire protection engineering firms.

The Department will issue individual Work Orders including the scope of work and a not-to-exceed amount to the contractor. The not-to-exceed amount for the individual Work Orders will vary; however, the cumulative sum of the Work Orders will not exceed the maximum amount of the Agreement. Any increase above the amount or term of the Agreement(s) would be submitted to your Board for approval.

The contractors have agreed to comply with the County's Contractor Employee Jury Service Ordinance, as well as all other contract provisions that are required by County ordinance and administrative memoranda, including but not limited to, minimum insurance requirements, hold harmless clauses, and non-discrimination and equal benefits policies.

County Counsel has reviewed and approved the Resolution and Agreements as to form.

Approval of these Agreements contributes to the Shared Vision 2025 outcome of Collaborative Community by approaching construction and renovation projects in County facilities with fiscal concern and accountability.

FISCAL IMPACT:

The terms of these Agreements are from July 1, 2014 through June 30, 2017. The not to exceed amount for these Agreements is \$300,000 per agreement, or \$600,000 in aggregate. There is no impact to the General Fund as individual work orders will be funded through previously approved and appropriated projects.
