RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH CARDINAL HEALTH PHARMACY SERVICES, LLC TO PROVIDE REMOTE ORDER ENTRY PHARMACY SERVICES, EXTENDING THE TERM THROUGH JUNE 30, 2016, AND INCREASING THE AMOUNT BY \$185,000 TO AN AMOUNT NOT TO EXCEED \$785,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in September of 2010, the Centers for Medicare & Medicaid Services (CMS) found that San Mateo Medical Center (SMMC) was not in compliance with CMS conditions of participation because a pharmacist did not always review afterhours medication orders when the SMMC pharmacy is closed prior to administration of a patient's first dose; and

WHEREAS, in March 2011, SMMC conducted a Request for Proposals (RFP) for a vendor to provide these services; and

WHEREAS, on July 12, 2011, your Board approved an agreement with Cardinal Health Pharmacy Services, LLC (Cardinal) to provide Remote Order Entry services during the hours when the SMMC pharmacy is closed; and

WHEREAS, on November 21, 2013, the Chief Executive Officer of SMMC approved an amendment that reduced the minimum monthly service levels to reflect

SMMC's usage and extended the term of the agreement by one year; and

WHEREAS, with the recent changes in the contracted hospitalists servicing SMMC's Emergency Room and the October implementation of the ICD-10 coding initiative it would be disruptive and cost prohibitive to change vendors for this service at this time; and

WHEREAS, therefore, the Director of Pharmacy believes it is in the best interest of the County for Cardinal to continue to provide these services for an additional year, permitting SMMC to issue an RFP in Fall 2015 to find a vendor to provide these services starting in Spring 2016; and

WHEREAS, both parties wish to enter into an amendment to the Agreement to allow Cardinal to provide these services for an additional year and increasing the amount by \$185,000 to an amount not to exceed \$785,000; and

WHEREAS, this Board has been presented with a form of such Amendment, has examined and approved it as to both form and content, and desires to enter into it.

THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of this Board of Supervisors be and is hereby authorized and directed to

execute said Amendment for and on behalf of the County of San Mateo, and the Clerk

of the Board shall attest the President's signature thereto
