Re: Pharmacy Services Agreement effective July 1, 2011 between San Mateo Medical Center and Cardinal Health Pharmacy Services, LLC ("Agreement")

Dear Mr. Horne:

Effective April 1, 2015, this letter serves to extend the above-referenced Agreement for an additional fourteen (14) months and to increase the fiscal obligation of the Agreement.

Paragraph 2.04 (d) and 4.03 of the Agreement are replaced in their entirety as follows:

2.04 Monthly Fees

d. Total Contract Value and Not To Exceed Amount. The Parties agree that this contract is valued at five hundred seventy-six thousand dollars (\$576,000). This is based on an estimated volume of four thousand (4,000) Order Lines processed each month at four dollars (\$4.00) per Order Line for a period of thirty-six (36) months. Actual contract value may be higher or lower should Customer's Order Line volume exceed or not reach four thousand (4,000) Order Lines per month and based on other factors. However, in no circumstance shall Customer's fiscal obligation under this Agreement exceed \$785,000 for services under this Agreement, and Cardinal Health shall not be required to perform services beyond this not-to-exceed amount. Any change in this amount requires a written amendment to this Agreement.

4.03 Termination Date The term of this Agreement shall end on June 30, 2016, unless subject to earlier termination as set forth below ("**Termination Date**").

Upon two (2) weeks' prior written notice to the Cardinal Health Center Director, and subject to Cardinal Health's pharmacy service center staff availability, Customer in its reasonable discretion may change its designated Hours of Service without necessity of an amendment.

All terms and conditions of the Agreement not supplanted or supplemented herein shall remain unaltered and in full force and effect. To the extent that there is any conflict between this Letter Agreement and the Agreement, this Letter Agreement shall control.

This Agreement may be executed in one or more counterparts, each of which shall constitute an original, but all of which together shall constitute one instrument. Signatures to this Agreement may be delivered by facsimile, by electronic mail (e.g., a ".pdf" file) or by any other electronic means that is intended to preserve the original appearance of the document, and such delivery will have the same effect as the delivery of the paper document bearing the actual, handwritten signatures.
