POSITIONS, ADD FIVE POSITIONS, SPLIT TWO POSITIONS TO HALF-TIME AND  
CONVERT ONE POSITION TO CLASSIFIED.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 073703 as follows:

Organization 14000 CONTROLLER'S OFFICE

1. Item E539S, Accountant Series - Confidential is decreased by 1 position for a new total of 0 positions.
2. Item E004, Senior Accountant - Confidential is increased by 1 position for a new

total of 1 position.

Organization 26000 DEPARTMENT OF CHILD SUPPORT

1. Item B330, Child Support Customer Service Specialist is decreased by 1 position for a new total of 1 position.
2. Item E350, Fiscal Office Specialist is increased by 1 position for a new total of 1 position.

Organization 61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES

1. Item E411S, Patient Services Assistant Series is decreased by 1 position for a new total of 20 positions.
2. Item E420, Medical Office Specialist is increased by 1 position for a new total of 10 positions.
