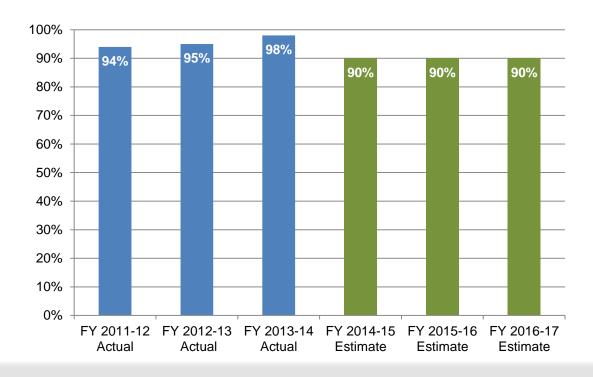

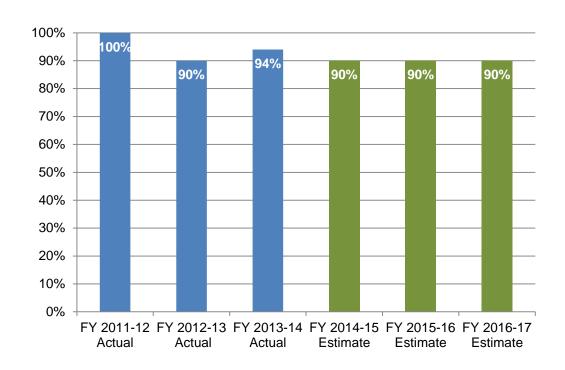
Controller's Office Key Performance Measures

FY 2013-15 Accomplishments

- Received Government Finance Officers Association (GFOA)
 Awards for Excellence in Financial Reporting
- Implemented new HR-Payroll system in collaboration with HR, ISD and CMO
- Worked with SamCERA, audit and actuarial firms to prepare for implementation of GASB 68 (Pension Reporting Requirements) in FY 2014-15 financial report
- Selected system hosting provider and initiated migration of Property Tax System to the Cloud in collaboration with Tax Collector and ISD

FY 2013-15 Accomplishments

- Implemented new Accounts Payable Invoice Automation pilot system to reduce manual processes and improve online access to information and electronic documents
- Implemented automated processes to enable continuous monitoring and data analysis of financial transactions to ensure compliance with policies and procedures
- Worked with Assessor, Tax Collector and ISD to document business requirements for an integrated Assessment and Property Tax System
- Implemented new e-Payables program to pay vendors via merchants' credit card accounts instead of paper checks

FY 2015-17 Challenges

- Ability to attract qualified candidates to fill highly-specialized positions
- Prioritizing use of subject matter experts to implement new systems and initiatives, in addition to supporting daily operations
- Availability of single integrated Assessment and Property Tax System that meets County's business requirements

FY 2015-17 Priorities

- Complete upgrade of County's financial accounting system (IFAS) and countywide roll-out to 300+ system users
- Collaborate with Assessor, Tax Collector and ISD to issue a RFP and evaluate potential solutions for an integrated Assessment and Property Tax System
- Prepare GFOA award-winning annual financial reports (CAFRs and PAFRs) of the County
- Complete migration of existing Property Tax System to a cloudbased hosted environment

FY 2015-17 Priorities

- Conduct internal control reviews of countywide and departmentspecific financial-related systems
- Perform risk-based performance audits of divisions, programs and specific activities to improve operational and financial results
- Implement Accounts Payable Invoice Automation system countywide, and expand use of ePayables program
- Optimize payroll system functions, business processes, and user support activities related to use of new HR-Payroll system
- Work with CMO and departments to conduct business process improvement reviews (LEAN initiatives)
