RESOLUTION AUTHORIZING: A) THE CONSOLIDATION OF THE PRESIDENTIAL PRIMARY ELECTION, TO BE HELD ON TUESDAY, JUNE 7, 2016, WITH ELECTIONS CALLED BY THE JEFFERSON UNION HIGH SCHOOL DISTRICT, PACIFICA SCHOOL DISTRICT, RAVENSWOOD CITY SCHOOL DISTRICT, COUNTY OF SAN MATEO, CITY OF HALF MOON BAY, AND SAN FRANCISCO BAY RESTORATION AUTHORITY; AND B) THE COUNTY'S CHIEF ELECTIONS OFFICER TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION THEREWITH.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, pursuant to Section 12000 of the Elections Code, the Governor proclaimed a Presidential Primary Election will be held on Tuesday, June 7, 2016, including statewide offices, qualified constitutional amendments, questions, and propositions (the "Presidential Primary Election"); and

WHEREAS, pursuant to state law, the County's Chief Elections Officer has called and shall conduct the scheduled Presidential Primary Election throughout the County of San Mateo on Tuesday, June 7, 2016; and

WHEREAS, Sections 10400 through 10418 of the Elections Code authorize the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections and provide that, where one of the elections is a statewide election, the consolidation may be ordered by the County Board of Supervisors upon request and the consolidated

election shall be held in all respects as if it were one election, with the returns being canvassed by the County elections official; and

WHEREAS, pursuant to state law, the Board of Trustees of the Jefferson Union High School District adopted Resolution No. 2015-16/10 calling an election on Tuesday, June 7, 2016, for the purposes of submitting a parcel tax measure to voters in the Jefferson Union High School District and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Education of the Pacifica School District adopted Resolution No. 2016-03-02-A calling an election on Tuesday, June 7, 2016, for the purposes of submitting a parcel tax measure to voters in the Pacifica School District and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefore; and

WHEREAS, pursuant to state law, the Board of Trustees of the Ravenswood City School District adopted Resolution No. 1166 calling an election on Tuesday, June 7, 2016, for the purposes of submitting a bond measure to voters in the Ravenswood City School District and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Supervisors of the County of

San Mateo adopted Resolution No. 074361 calling an election on Tuesday, June 7, 2016, for the purpose of submitting a parcel tax measure to voters in Service Area No. 1 and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefore; and

WHEREAS, pursuant to state law, the City Council of the City of Half Moon Bay adopted Resolution No. C-2015- giving notice of a special election to be held on June 7, 2016, for the purpose of submitting the "Taxpayer Protection Act" to voters in the City of Half Moon Bay and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefore; and

WHEREAS, pursuant to state law, the San Francisco Bay Restoration Authority Governing Board adopted Resolutions No. 13 and 14 giving notice of a special election to be held on June 7, 2016, for the purpose of submitting a parcel tax to voters in the County of San Mateo and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefore; and

WHEREAS, the County's Chief Elections Officer is agreeable to providing specified election services as duly requested and enumerated above in conjunction with the Presidential Primary Election to be held on Tuesday, June 7, 2016; and

WHEREAS, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant to Section 5421 of the California Education Code (except for the cost to administer vote

by mail ballots pursuant to Section 3024 of the Elections Code), and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the California Elections Code;

WHEREAS, in consideration of the services and supplies to be provided by the Chief Elections Officer in conducting said election, the Jefferson Union High School District, Pacifica School District, Ravenswood City School District, City of Half Moon Bay and San Francisco Bay Restoration Authority will enter into separate agreements to reimburse the County for the costs of said services and supplies as outlined above.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that (1) the June 7, 2016 Presidential Primary Election is hereby consolidated with the above-named local elections duly called by their respective governing bodies; and (2) the Chief Elections Officer is authorized to render specified election services in conjunction therewith.
