WHEREAS, for the past 32 years, **LIEUTENANT DAVID MACKRISS** has demonstrated exemplary service to the residents of Daly City within the Daly City Police Department; and

WHEREAS, **LIEUTENANT DAVID MACKRISS** started in Daly City as a police explorer in 1977 was appointed a police officer on July 17, 1983, and initially started his career as a California State Police Officer who became one of the first lateral police officers to work in Daly City's police department; and

WHEREAS, **LIEUTENANT DAVID MACKRISS** grew up in Daly City and attended Westlake Elementary School, Fernando Rivera Junior High and Serramonte High School, and graduated from San Francisco State University with a Bachelor of Arts in Sociology; and

WHEREAS, **LIEUTENANT DAVID MACKRISS**, having earned the respect of the Daly City community and the esteem of his peers, was promoted to Sergeant in 2000 and Lieutenant in 2011; and

WHEREAS, **LIEUTENANT DAVID MACKRISS** began a distinguished three decades long career which included working as a Range Master, Background Officer, Detective Commander, Motorcycle Officer, Hostage Team Leader and Commander, Internal Affairs Sergeant, Public Information Officer and was a leader in DUI Enforcement details; and

WHEREAS, **LIEUTENANT DAVID MACKRISS'** outstanding performance has been recognized for being instrumental in detecting stolen vehicles and has received an unprecedented twenty-six Vehicle Code "10851" pins which were awarded from the California Highway Patrol and AAA to recognize his outstanding achievement in the detection, investigation and apprehension of automobile thieves; and

WHEREAS, **LIEUTENANT DAVID MACKRISS** has made significant contributions to the safety and well-being of the residents of Daly City and the entire San Mateo County community.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of San Mateo County congratulates and commends **LIEUTENANT DAVID MACKRISS** upon his retirement from the Daly City Police Department.
