RESOLUTION AUTHORIZING AMENDMENTS TO THE AGREEMENTS WITH "ON-CALL" ARCHITECTURAL DESIGN CONSULTING SERVICE FIRMS CJW ARCHITECTURE AND DREYFUSS AND BLACKFORD ARCHITECTS, TO CONTINUE PROVIDING ON-CALL ARCHITECTURAL PROFESSIONAL SERVICES FOR CAPITAL PROJECTS AND FACILITIES, INCREASING CJW ARCHITECTURE AGREEMENT THE NOT-TO-EXCEED AMOUNT BY \$200,000, FOR A NEW TOTAL NOT-TO-EXCEED AMOUNT OF \$700,000; AND INCREASING THE DREYFUSS AND BLACKFORD ARCHITECTS AGREEMENT NOT-TO-EXCEED AMOUNT BY \$300,000, FOR A NEW TOTAL NOT-TO-EXCEED AMOUNT OF \$800,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of

California, that

WHEREAS, on November 17, 2015, this Board of Supervisors did authorize the

Department of Public Works to engage the services of professional design engineering

technical experts; and

WHEREAS, the County of San Mateo executed agreements with architectural

consulting firms: CJW Architecture and Dreyfuss and Blackfrod Architects with each

agreement having a three-year term from November 17, 2015 through November 16,

2018; and

WHEREAS, the Director of Public Works would like to continue the extensive work both firms are conducting for the County Center Master Plan, the Tower Road Master Plan, and the Maple Street Shelter Renovation projects; and

WHEREAS, the parties now wish to amend the agreements to increase the

amount of the agreements for CJW Architecture by not more than \$200,000 for a new not-to-exceed amount of \$700,000; and Dreyfuss and Blackford Architects by not more than the amount of \$300,000 for a new not-to-exceed amount of \$800,000.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board of Supervisors be and is hereby authorized and directed to execute said amendments to the agreements with CJW Architecture and Dreyfuss and Blackford Architects; to increase the not-to-exceed amounts for the agreements by \$200,000 for a new not-to-exceed amount of \$700,000 for CJW Architecture; and \$300,000 for a new not-to-exceed amount of \$800,000 for Dreyfuss and Blackford Architects; for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signatures thereto.

BE IT FURTHER RESOLVED that the Director of Public Works, and/or his designee, is authorized to execute contract amendments which modifies the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
