**RESOLUTION AUTHORIZING AN AGREEMENT WITH DIGITAL DEPLOYMENT, INC. TO COLLABORATE WITH SAN MATEO COUNTY HEALTH SYSTEM FOR WEB REDESIGN, CONTENT MIGRATION AND IMPLEMENTATION, AND TO PROVIDE WEBSITE SERVICES, SUPPORT AND HOSTING FOR SMCHEALTH.ORG, SANMATEOMEDICALCENTER.ORG, AND GETHEALTHYSMC.ORG, FOR THE TERM OF OCTOBER 6, 2015 THROUGH JUNE 30, 2018, IN AN AMOUNT NOT TO EXCEED \$540,750**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, The number of people who get health information and services online continues to increase and the best practices and technology used to deliver that information continues to grow and improve; and

**WHEREAS**, new online best practices and technology supports the Health System's mission of helping San Mateo County residents live longer and better lives; and

**WHEREAS**, the Health System strives to provide San Mateo County residents with the right services, at the right time and place by using best practices and new technology, such as self-service; and

**WHEREAS**, the Health System strives to keep up with current best practices and technology to be the provider of choice and to maintain standards of excellence; and

**WHEREAS,** a Request for Proposal (RFP) for Website and Hosting Services for Drupal Sites was issued on March 6, 2015 and Digital Deployment, was determined to be the best fit based on relevant clients, expertise, cost, and overall strategy and was awarded the contract in early July, 2015; and

**WHEREAS,** both parties now wish to execute an agreement with Digital Deployment to collaborate with the Health System for web redesign, content migration and implementation, and to provide website services, support and hosting for the Health System effective October 6, 2015 through June 30, 2018, in an amount not to exceed of \$540,750; and

**WHEREAS,** this Board has been presented with the Agreement and has approved it as to both form and content and desires to enter into the Agreement; and

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board of Supervisor be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto; and

**BE IT FURTHER RESOLVED,** that the Chief of the Health System or designee is Authorized to execute contracts amendments which modify the county's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
