RESOLUTION: A) CONSOLIDATING THE MUNICIPAL, SCHOOL AND SPECIAL DISTRICT ALL-MAILED BALLOT ELECTION, TO BE HELD ON TUESDAY, NOVEMBER 3, 2015, WITH ELECTIONS CALLED BY THE SAN MATEO COUNTY COMMUNITY COLLEGE DISTRICT, BELMONT-REDWOOD SHORES SCHOOL DISTRICT, HILLSBOROUGH CITY SCHOOL DISTRICT, JEFFERSON ELEMENTARY SCHOOL DISTRICT, REDWOOD CITY SCHOOL DISTRICT, SAN BRUNO PARK SCHOOL DISTRICT, SAN CARLOS SCHOOL DISTRICT, SAN MATEO UNION HIGH SCHOOL DISTRICT, SAN MATEO-FOSTER CITY SCHOOL DISTRICT, SEQUOIA UNION HIGH SCHOOL DISTRICT, WOODSIDE ELEMENTARY SCHOOL DISTRICT, CITY OF BELMONT, CITY OF BRISBANE, CITY OF BURLINGAME, CITY OF FOSTER CITY, CITY OF MILLBRAE, CITY OF REDWOOD CITY, CITY OF SAN BRUNO, CITY OF SAN CARLOS, CITY OF SAN MATEO, CITY OF SOUTH SAN FRANCISCO, TOWN OF WOODSIDE, BROADMOOR POLICE PROTECTION DISTRICT, AND MENLO PARK FIRE PROTECTION DISTRICT; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION THEREWITH.

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Sections 10400 through 10418 of the California Elections Code authorize the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections, the consolidation may be ordered by the County Board of Supervisors upon request, and the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer;;

WHEREAS, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant

to Section 5421 of the California Education Code, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the California Elections Code

WHEREAS, the San Mateo County Community College District, Belmont-Redwood Shores School District, Hillsborough City School District, Jefferson Elementary School District, Redwood City School District, San Bruno Park School District, San Carlos School District, San Mateo Union High School District, San Mateo-Foster City School District, Sequoia Union High School District, and Woodside Elementary School District are required to hold regularly scheduled governing board elections, and the named districts have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote and are requesting an election as more candidates have filed to run for office in the named districts than there are seats available;

WHEREAS, pursuant to state law, the Broadmoor Police Protection District is required to hold regularly scheduled governing board elections, and the named district has notified the County's Chief Elections Officer of the number of seats to be elected and the boundaries of the district and is requesting an election as more candidates have filed to run for office in the named district than there are seats available;;

WHEREAS, , pursuant to state law, the governing board of the Redwood City School District adopted Resolution No. 1, giving notice of a special election to be held on November 3, 2015, for the purpose of submitting a bond measure to District voters

and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor;;

WHEREAS, , pursuant to state law, the governing board of the San Mateo-Foster City School District adopted Resolution No. 01/15-16, giving notice of a special election to be held on November 3, 2015, for the purpose of submitting a bond measure to District voters and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor;

WHEREAS, pursuant to state law, the City of Belmont adopted Resolution No. 2015-063, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing two city council members, one city clerk, and one city treasurer for a term of four years and requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services to the City therefor;

WHEREAS, pursuant to state law, the City of Brisbane adopted Resolution No. 2015-22, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing two city council members for a term of four years and requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services to the City therefor;;

WHEREAS, pursuant to state law, the City of Burlingame adopted Resolution No. 55-2015, giving notice of holding a regularly scheduled general municipal election to

be held on November 3, 2015, for the purpose of electing two city council members for a term of four years and requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services to the City therefor; and;
and

WHEREAS, pursuant to state law, the City of Foster City adopted Resolution No. 2015-48, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing three city council members for a term of four years and requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services to the City therefor;; and

WHEREAS, , pursuant to state law, the City of Millbrae adopted Resolution Nos. 15-26, 15-27, and 15-28, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing three city council members for a term of four years and requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services to the City therefor;; and

WHEREAS, pursuant to state law, the City of Redwood City adopted Resolution No. 15424, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing four city council members for a term of four years and requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, pursuant to state law, the City of San Bruno adopted Resolution Nos. 2015-62, 2015-48, and 2015-49, giving notice of a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing one mayor for a two-year term and two city council members for four-year terms, submitting to San Bruno Voters measures to make the positions of City Clerk and City Treasurer appointive, and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, pursuant to state law, the City of San Carlos adopted Resolution No. 2015-066 and Ordinance No. 1493 giving notice of a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing two city council members and one city treasurer for four-year terms, submitting to San Carlos Voters a bond measure, and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, pursuant to state law, the City Council of the City of San Mateo adopted Resolution Nos. 58 (2015) and 81 (2015), giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing two city council members for four-year terms and one city council member to a two-year term, submitting to San Mateo Voters a measure for a transaction and use tax, and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, pursuant to state law, the City Council of the City of South San Francisco adopted Resolution Nos. 48-2015 and 90-2015, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing two city council members for four-year terms, submitting to South San Francisco Voters a measure for a transaction and use tax, and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

WHEREAS, pursuant to state law the Town Council of the Town of Woodside adopted Resolution No. 2015-7047, giving notice of a regularly scheduled general municipal election to be held on November 3, 2015, for the purpose of electing one District 1 town council member, one District 3 town council member, one District 5 town council member, and one District 7 town council member for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the Town therefor; and

WHEREAS, pursuant to state law, the governing body of Menlo Park Fire Protection District adopted Resolution No. 1801-20115, giving notice of holding a special election to be held on November 3, 2015, for the purpose of submitting a continuance of appropriations limit measure to District voters, requesting the Board of Supervisors to authorize the County's Chief Elections Officer to render specified election services therefor, and authorizing a service agreement for such services to be executed between the County and the district; and

WHEREAS, , the County's Chief Elections Officer is agreeable to providing the specified election services as duly requested and enumerated above in conjunction with the Consolidated Municipal, School and Special District Election to be held on Tuesday, November 3, 2015; and

WHEREAS, said Consolidated Municipal, School and Special District Election to be held on Tuesday, November 3, 2015, shall be conducted wholly by mail as a pilot program as authorized by Section 4001 of the Elections Code; and

WHEREAS, in consideration of the services and supplies to be provided by the Chief Elections Officer in conducting said election, the above-named cities and districts as required by law will enter into separate agreements with the County's Chief Elections Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.; and

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that (1) the November 3, 2015 Consolidated Municipal, School and Special District Election is hereby consolidated with the above-named local elections duly called by their respective governing bodies and (2) the Chief Elections Officer is authorized to render specified election services in conjunction therewith.
