AN ORDINANCE AMENDING SECTIONS 2.02.020, 2.02.030, 2.02.040, 2.02.050 AND
2.02.060 OF CHAPTER 2.02, OF TITLE 2 OF THE SAN MATEO COUNTY
ORDINANCE CODE
ESTABLISHING THE BOUNDARIES OF THE SUPERVISORIAL DISTRICTS

The Board of Supervisors of the County of San Mateo, State of California,

ORDAINS as follows:

SECTION 1. Section 2.02.020 is hereby amended to read as follows:

Section 2.02.020. First Supervisorial District:

The First Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the intersection of the County border, the Brisbane border, and the South San Francisco border; thence proceeding westerly along the border of South San Francisco to McLellan Drive; thence proceeding southerly along McLellan to El Camino Real; thence proceeding westerly along El Camino Real to Hickey Boulevard; thence proceeding westerly along Hickey to Junipero Serra Blvd; thence proceeding southerly along Junipero Serra to Avalon Dr; thence proceeding westerly along Avalon Dr to I-280; thence proceeding southerly along I-280 to Sneath Ln; thence proceeding westerly along Sneath Ln to Skyline Blvd; thence proceeding southerly along Skyline to the southern border of San Bruno; thence proceeding easterly along the border of San Bruno to I-280; thence proceeding southerly along I-280 to the border of Millbrae; thence proceeding southerly along the border of Millbrae to I-280; thence proceeding southerly along I-280 to Highway 92; thence proceeding easterly along Highway 92 to the city border of San Mateo; thence proceeding clockwise along the San Mateo city border to the county border; thence thence counter-clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 2. Section 2.02.030 is hereby amended to read as follows:

Section 2.02.030. Second Supervisorial District:

The Second Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the border of the County, Redwood City and Foster City; thence proceeding clockwise along the border of Foster City to Belmont; thence proceeding clockwise along the border of Belmont to Old Country Road; thence proceeding northerly along Old Country Road to O'Neill Avenue; thence proceeding easterly along O'Neill Avenue to El Camino Real; thence proceeding northerly along El Camino Real to Middle Road; thence proceeding northwesterly along Middle Road to Hainline Drive; thence proceeding westerly and southerly along Hainline to South Road; thence proceeding westerly along South Road to Middle Road; thence proceeding southwesterly along Middle to Notre Dame Road; thence proceeding northwesterly and southerly along Notre Dame Road to Arbor Ave; thence proceeding westerly along Arbor Ave to Fairway Drive; thence proceeding southerly and easterly along Fairway Drive to Avon Street; thence proceeding southerly along Avon to Ralston Avenue; thence proceeding westerly along Ralston to Coronet Blvd; thence proceeding southerly along Coronet Blvd to Merry Moppet Lane; thence proceeding westerly along Merry Moppet Lane to Carlmont Drive; thence proceeding westerly along Carlmont Drive to Mullberry Court; thence proceeding southerly along Mullberry Court and its extension along the western border of Census Block 060816089002004 to Hastings Drive; thence proceeding westerly and southerly along Hastings Drive to Whiteridge Road; thence proceeding southerly along Whiteridge to the northern border of San Carlos; thence proceeding counter-clockwise along the city border to the unnamed road at the southern border of Census Block 060816089001010; thence proceeding westerly along the unnamed road to Interstate 280; thence proceeding northerly along I-280 to Highway 92; thence proceeding westerly along Highway 92 to the border of San Mateo; thence proceeding clockwise along the city border to the county border; thence proceeding clockwise along the county border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 3. Section 2.02.040 is hereby amended to read as follows:

Section 2.02.040 Third Supervisorial District:

The Third Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the intersection of Interstate 280 and the southern county border; thence proceeding northerly along I-280 to the city border of Menlo

Park; thence proceeding clockwise along the city border to the intersection for the Menlo Park border, the Atherton border, and Arlington Way; thence proceeding counter-clockwise along the Atherton border to the Redwood City border; thence proceeding clockwise along the Redwood City border to Steinberger Slough; thence proceeding northerly along Steinberger Slough to the bay; thence proceeding westerly along the bay border of Redwood City to the intersection of the borders of Redwood City and Foster City; thence proceeding clockwise along the border of Foster City to Belmont; thence proceeding clockwise along the border of Belmont to Old Country Road; thence proceeding northerly along Old Country Road to O'Neill Avenue; thence proceeding easterly along O'Neill Avenue to El Camino Real; thence proceeding northerly along El Camino Real to Middle Road; thence proceeding northwesterly along Middle Road to Hainline Drive; thence proceeding westerly and southerly along Hainline to South Road; thence proceeding westerly along South Road to Middle Road; thence proceeding southwestly along Middle to Notre Dame Road; thence proceeding northwesterly and southerly along Notre Dame Road to Arbor Ave; thence proceeding westerly along Arbor Ave to Fairway Drive; thence proceeding southerly and easterly along Fairway Drive to Avon Street; thence proceeding southerly along Avon to Ralston Avenue; thence proceeding westerly along Ralston to Coronet Blvd; thence proceeding southerly along Coronet Blvd to Merry Moppet Lane; thence proceeding westerly along Merry Moppet Lane to Carlmont Drive; thence proceeding westerly along Carlmont Drive to Mulberry Court; thence proceeding southerly along Mulberry Court and its extension along the western border of Census Block 060816089002004 to Hastings Drive; thence proceeding westerly and southerly along Hastings Drive to Whiteridge Road; thence proceeding southerly along Whiteridge to the northern border of San Carlos; thence proceeding counter-clockwise along the city border to the unnamed road at the southern border of Census Block 060816089001010; thence proceeding westerly along the unnamed road to Interstate 280; thence proceeding northerly along I-280 to the border of Millbrae; thence proceeding northerly along the border of Millbrae to I-280; thence proceeding northerly along I-280 to the border of San Bruno; thence proceeding northerly and westerly along the border of San Bruno to Pacifica; thence proceeding northerly along the border of Pacifica to the Pacific Ocean and the County border; thence proceeding counter-clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 4. Section 2.02.050 is hereby amended to read as follows:

Section 2.02.050. Fourth Supervisorial District:

The Fourth Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the intersection of Interstate 280 and the southern county border; thence proceeding northerly along I-280 to the city border of Menlo Park; thence proceeding clockwise along the city border to the intersection for the Menlo Park border, the Atherton border, and Arlington Way; thence proceeding counter-clockwise along the Atherton border to the Redwood City border; thence proceeding clockwise along the Redwood City border to Steinberger Slough; thence proceeding northerly along Steinberger Slough to the bay; thence proceeding westerly along the bay border of Redwood City to the border of Foster City; thence proceeding clockwise along the border of Foster City and Redwood City to the County border; thence proceeding clockwise along the county border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 5. Section 2.176.060 is hereby amended to read as follows:

Section 2.176.060. Fifth Supervisorial District:

The Fifth Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the intersection of the County's western border, the Pacific Ocean, and the northern border of Pacifica; thence proceeding easterly and southerly along the border of Pacifica past Sneath Rd to the border of San Bruno; thence proceeding easterly along the San Bruno border and its easterly extension to Skyline Blvd; thence proceeding northerly along Skyline Blvd to Sneath Ln; thence proceeding easterly along Sneath Ln to Interstate 280; thence proceeding northerly along I-280 to Avalon Dr; thence proceeding easterly along Avalon Dr to Junipero Serra Blvd; thence proceeding northerly along Junipero Serra to Hickey Boulevard; thence proceeding easterly along Hickey to El Camino Real; thence proceeding easterly along El Camino Real to McLellan Drive; thence proceeding northerly along McLellan to the border of South San Francisco; thence proceeding easterly along the border of South San Francisco to the County border; thence proceeding counter-clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 6. This ordinance shall be effective thirty (30) days from the date of passage thereof.
