**AN ORDINANCE AMENDING SECTIONS 2.02.020, 2.02.030, 2.02.040, 2.02.050 AND
2.02.060 OF CHAPTER 2.02, OF TITLE 2 OF THE SAN MATEO COUNTY
ORDINANCE CODE
ESTABLISHING THE BOUNDARIES OF THE SUPERVISORIAL DISTRICTS**

The Board of Supervisors of the County of San Mateo, State of California,
ORDAINS as follows:

SECTION 1. Section 2.02.020 is hereby amended to read as follows:

Section 2.02.020. First Supervisorial District:

The First Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the border of San Mateo and Foster City in the tidelands north of East 3rd Ave between Census Blocks 060816061001018 and 060816080044001; thence proceeding southerly along the city border to East 3Rd Ave, thence proceeding westerly along E 3rd Ave across the inlet and proceeding southerly, easterly, southerly, westerly, and southerly along the western shore of the inlet to the north border of Bayside/Joinville Park; thence proceeding westerly along the Bay inlet marking the north border of Bayside/Joinville Park and the Bayside S.T.E.M. Academy to the southerly turn in the inlet; thence proceeding southerly and southwesterly along the inlet to Interstate 101; thence proceeding northerly along I-101 to E 5th Ave; thence proceeding southwesterly along E 5th Ave to the Caltrain Railroad line; thence proceeding northwesterly along the railroad to Catalapa St; thence proceeding westerly along Catalapa St to Ellsworth Ave; thence proceeding northwesterly along Ellsworth Ave to E Poplar Ave; thence proceeding easterly along Poplar Ave to the railroad; thence proceeding northwesterly along the railroad to Grand Blvd; thence proceeding easterly along Grand to Claremont St; thence proceeding southerly along Claremont St to Bellevue Ave; thence proceeding easterly along Bellevue Ave to Delaware St; thence proceeding southerly along Delaware St to Poplar Ave; thence proceeding northeasterly along Poplar

Ave to Humboldt St; thence proceeding northerly along Humboldt St to the border of San Mateo and Burlingame; thence proceeding southwesterly along the border of Burlingame to Hillsborough; thence proceeding northwesterly and westerly along the Hillsborough city border to Interstate 280; thence proceeding northerly along I-280 to the border of Millbrae; thence proceeding northerly along the border of Millbrae to I-280; thence proceeding northerly along I-280 to the border of San Bruno; thence proceeding northerly and westerly along the border of San Bruno to Pacifica; thence proceeding northerly along the border of Pacifica to South San Francisco; thence proceeding easterly along the border of South San Francisco to I-280; thence proceeding northerly along I-280 to Westborough Blvd; thence proceeding northeasterly along Westborough Blvd and Chestnut Ave to Hillside Blvd; thence proceeding easterly along Hillside Blvd and Sister Cities Blvd to the eastern edge of Census Block 060816020001014 (at the extension of Belmont Ave); thence proceeding due north through South San Francisco and San Bruno Mountain Park along the western borders of Census Blocks 060816020001010, 060816020001011, 060816001001065, 060816001001063 and 060816020001009 to the border of Bisbee; thence proceeding northerly along the western border of Bisbee to the County border; thence proceeding clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 2. Section 2.02.030 is hereby amended to read as follows:

Section 2.02.030. Second Supervisorial District:

The Second Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the border of San Mateo and Foster City in the tidelands north of East 3rd Ave between Census Blocks 060816061001018 and 060816080044001; thence proceeding southerly along the city border to East 3Rd Ave, thence proceeding westerly along E 3rd Ave across the inlet and proceeding southerly, easterly, southerly, westerly, and southerly along the western shore of the inlet to the north border of Bayside/Joinville Park; thence proceeding westerly along the Bay inlet marking the north border of Bayside/Joinville Park and the Bayside S.T.E.M. Academy to the southerly turn in the inlet; thence proceeding southerly and southwesterly along the inlet to Interstate 101; thence proceeding northerly along I-101 to E 5th Ave; thence proceeding southwesterly along E 5th Ave to the Caltrain Railroad line; thence proceeding northwesterly along the railroad to Catalapa St; thence proceeding westerly along Catalapa St to Ellsworth Ave; thence proceeding northwesterly along Ellsworth Ave to E Poplar Ave; thence proceeding easterly along Poplar Ave to the railroad; thence proceeding northwesterly along the railroad to Grand Blvd; thence

proceeding easterly along Grand to Claremont St; thence proceeding southerly along Claremont St to Bellevue Ave; thence proceeding easterly along Bellevue Ave to Delaware St; thence proceeding southerly along Delaware St to Poplar Ave; thence proceeding northeasterly along Poplar Ave to Humboldt St; thence proceeding northerly along Humboldt St to the border of San Mateo and Burlingame; thence proceeding southwesterly along the border of Burlingame to Hillsborough; thence proceeding northwesterly and westerly along the Hillsborough city border to Interstate 280; thence proceeding southerly along I-280 to the unnamed eastern exit west of Club Drive at the border of Census Blocks 060816089001013 and 060816096031005; thence proceeding easterly along the northern borders of Census Blocks 060816096031005, 060816096031004, and 060816096031001 to the border of San Carlos; thence proceeding northerly to the border of Belmont; thence proceeding easterly along the border of Belmont to Old Country Road and the border of San Carlos; thence proceeding easterly along the border of San Carlos to Interstate 101 and the border of Belmont; thence proceeding southerly, easterly, and northerly along the border of Belmont to Foster City; thence proceeding counter-clockwise along the border of Foster City to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 3. Section 2.02.040 is hereby amended to read as follows:

Section 2.02.040 Third Supervisorial District:

The Third Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning in Menlo Park at the intersection of the County border and Middlefield Rd; thence proceeding northerly along Middlefield Rd to Ringwood Rd and the border of Menlo Park; thence proceeding counter-clockwise along the border of Menlo Park to Bay Rd and the border of Atherton; thence proceeding counter-clockwise along the border of Atherton to Alameda; thence proceeding northwesterly along Alameda to Harcross Rd and the border of Redwood City; thence proceeding clockwise along the border of Redwood City to the intersection of the borders of Redwood City, San Carlos, and Belmont; thence proceeding westerly along the border of San Carlos to El Camino Real and the border of Belmont; thence proceeding westerly along the border of Belmont to Hallmark Dr and the border of San Carlos; thence proceeding westerly and southerly along the border of San Carlos to the intersection of the San Carlos border and the unnamed road exiting easterly off I-280 just west of Club Dr; thence proceeding westerly along the unnamed road to I-280; thence proceeding northerly along I-280 to the border of Millbrae; thence proceeding northerly along the border of Millbrae to I-280; thence proceeding northerly along I-280 to the border of San Bruno; thence

proceeding northerly and westerly along the border of San Bruno to Pacifica; thence proceeding northerly along the border of Pacifica to the Pacific Ocean and the County border; thence proceeding counter-clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 4. Section 2.02.050 is hereby amended to read as follows:

Section 2.02.050. Fourth Supervisorial District:

The Fourth Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning in Menlo Park at the intersection of the County border and Middlefield Rd; thence proceeding northerly along Middlefield Rd to Ringwood Rd and the border of Menlo Park; thence proceeding counter-clockwise along the border of Menlo Park to Bay Rd and the border of Atherton; thence proceeding counter-clockwise along the border of Atherton to Alameda; thence proceeding northwesterly along Alameda to Harcross Rd and the border of Redwood City; thence proceeding clockwise along the border of Redwood City to County border in the Bay; thence proceeding counter-clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 5. Section 2.176.060 is hereby amended to read as follows:

Section 2.176.060. Fifth Supervisorial District:

The Fifth Supervisorial District of the County of San Mateo, State of California, is hereby established and declared to be and contain all that territory of San Mateo County described as follows:

Beginning at the intersection of the County's western border, the Pacific Ocean, and the southern border of Daly City; thence proceeding easterly and southerly along the border of Daly City to the intersection of the borders of Daly City, Pacifica, and South San Francisco; thence proceeding southerly and easterly along the border of South San Francisco to Interstate 280; thence proceeding northerly along I-280 to Westborough Blvd; thence proceeding northeasterly along Westborough Blvd and Chestnut Ave to Hillside Blvd; thence proceeding easterly along Hillside Blvd and Sister Cities Blvd to the eastern edge of Census Block 060816020001014 (at the extension of Belmont Ave); thence proceeding due north through South San Francisco and San Bruno Mountain Park along the western borders of Census Blocks 060816020001010, 060816020001011, 060816001001065, 060816001001063 and 060816020001009 to the border of Bisbee; thence proceeding northerly

along the western border of Bisbee to the County border; thence proceeding counter-clockwise along the County border to the point of beginning; and depicted in a map that can be viewed in the County Offices.

SECTION 6. This ordinance shall be effective thirty (30) days from the date of passage thereof.
