RE: Phase I: Records Preservation Project

Dear Hon. Mark Church.

Please find the following pricing according to Kofile Preservation, Inc.'s CMAS Contract Number: 3-13-36-0096A for the data conversion (including preservation of the original source format, image capture, and image processing) of San Mateo County's 220 volumes. The goal is twofold: data preservation and access to vital assets. Please note that pricing is good for 90 days.

▶ This project addresses Deed Record Vols. 1—218, and Index to Homesteads Vols. 1 & 2. This collection dates as early as 1855. All of these records are in critically poor condition. All sheets measure 18" x 11 1/2".

Although our world and government is quickly moving into a paperless system, many records maintain permanent retention schedules. Kofile Preservation, Inc. (hereby Kofile) is uniquely qualified to complete San Mateo County's modernization and access goals.

### **SCOPE OF SERVICES**

Records will receive the following services. A permanent log is created for each volume or plat to record condition, page order, and services/treatments performed.

#### **Data Format: Miscellaneous Volumes**

Level of Service Code: PRV

Source Data: Analog Image Restoration

- Dismantle volumes.
- Surface clean sheets to remove deposits. This includes dust, soot, airborne particulate, sedimentation, insect detritus, or even biological/ mineral contaminants. Tools include a microspatula, dusting brush, latex sponge, powdered vinyl eraser, or block eraser.
- Remove any non-archival repairs or fasteners, such as residual glues. All tape and previous mends are reduced to the furthest extent possible without causing damage to paper and inks.
- Mend tears with Japanese tissue.
   All materials are acid free and reversible.


#### Source Data: Preservation

Deacidify sheets after careful testing. Magnesium oxide deacidifies (or neutralizes) acid inks and paper by providing an alkalize reserve. This chemical is inert and safe, and does not degrade the sheet. Random testing ensures an 8.5 pH with a deviation of no more than ± .5.

■ Encapsulate each sheet in a Lay Flat Archival Polyester Pocket™.

Each custom envelope is composed of SKC Films, Skyroll SH72S® Mylar and includes a patented lay flat design. This envelope is welded to prevent invasion of atmospheric pollutants.

- Volumes are rebound in a custom-fitted and stamped Heritage Recorder Binder or a Disaster Safe County Binder™ (DSB). A sample DSB is pictured below. A volume may return as two volumes, depending on page count. A dedication and treatment report is included in the binder.

- Final quality check with reference to original log sheet.

- San Mateo County receives one MASTER COPY (DVD or CD) and a COPY for upon completion.
- Kofile can hold a security copy for safe keeping. We do not sell, distribute, or grant unauthorized access to County records. They are strictly the County's property.

- Kofile Preservation, Inc.'s IMAGE PERFECT application software uses custom image clean up and enhancements such as deskew, despeckle, character repair, and zonal processing.
- Annotations are electronically added on the re-created image to assist in record keeping.
