Nack began his long and distinguished professional career in 1966 as a United Airlines Aircraft Jet Engine Mechanic in Journeyman Mechanic Status where he became a leader of Machinists Local Lodge 1781 having previously secured training and major accomplishments by earning Eagle Scout status, an Associate Degree in Aeronautics from the College of San Mateo and served in the U.S. Naval Reserve; and

Nack, having earned the respect of the labor community, was invited to join the Santa Clara and San Benito Counties Central Labor Council as Assistant Business Manager in 1987 and was later promoted to Santa Clara and San Benito Building and Construction Trades Council's Deputy Executive Officer in 1989, a position that made him responsible for all political and legislative activities; and

WHEREAS, William A. Nack continued to demonstrate a clear talent for management and public affairs and as a result was asked to serve as Business Manager/Executive Officer of the Building and Construction Trades Council of San Mateo County, AFL-CIO, and in this position led a council of 26 affiliated construction and other unions, a total membership of 14,000 union members and negotiated 45 Project Labor Agreements and Letters of Commitment totaling more than \$16,000,000,000 worth of construction projects; and

WHEREAS, William A. Nack has come to be regarded by his colleagues and throughout San Mateo County as a truly capable and dynamic leader having been selected to numerous boards and commissions including an appointment by the Governor of the State of California to the Bay Conservation and Development Commission and Cow Palace Board of Directors and by San Mateo County to the Bay Area Economic Forum, San Mateo County Community College District Bond Oversight Committee, among others; and

WHEREAS, William A. Nack, during his time as a labor leader, has made remarkable enhancements to the life of all workers and has left a legacy that will be experienced for generations to come.
