ADOPT A RESOLUTION 1) APROVING FUNDING FOR SIX GRANT APPLICATIONS FOR THE FY 2015-16 COMMUNITY CORRECTIONS PARTNERSHIP COMPETITIVE GRANT PROGRAM IN THE AGGREGATE AMOUNT OF \$773,982 AND 2) AUTHORIZING THE COUNTY MANAGER TO NEGOTIATE AND EXECUTE AGREEMENTS WITH JOB TRAIN, INC FOR THE MAXIMUM AMOUNT OF \$190,000 AND ONE EAST PALO ALTO FOR THE MAXIMUM AMOUNT OF \$195,000 FOR TERMS EXPIRING JUNE 30, 2016

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County Manager's Office has allocated \$1 million in public safety realignment funding for the funding of the Community Corrections Partnership Competitive Grant Program; and

WHEREAS, the County of San Mateo received \$250,000 in Community

Recidivism Reduction funding from the Board of State of Community Corrections to be allocated to County-based community organizations providing supportive and rehabilitative services to criminal justice involved persons; and

WHEREAS, the County Manager's Office issued a Request for Proposals in the Spring of 2015 to provide services to the County's public safety realignment and Unified Reentry populations both at high risk of recidivating; and

WHEREAS, a committee of staff from the Probation Department, Sheriff's Office, Service Connect and County Manager's Office reviewed the proposals and

recommended funding in the amount of \$190,000 to JobTrain, Inc. for job training, legal services, job placement and support services to the AB 109, PCRS, and 1170h population in order to obtain jobs and become contributing members of their communities; and \$195,000 for the One East Palo Alto which will provide supportive transitional housing services to the AB 109 and Unified Reentry population of East Palo Alto through its Neighborhood Improvement Initiative; and

WHEREAS, the Board has been presented with forms of such agreements, has examined them and has approved them as to both form and content and desires to authorize the County Manager or his designee to further negotiate and execute such agreements.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the County Manager or his designee is hereby authorized to negotiate and execute said agreements for and on behalf of the County of San Mateo, for an agreement amount not to exceed \$190,000 for JobTrain and \$195,000 for One East Palo Alto, for terms not to exceed June 30, 2016 for both agreements, pursuant to the County's standard contract provisions; and

**BE IT FURTHER RESOLVED** that the County Manager or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate per agreement), and/or modify the contract term and / or services so long as the term or services is/are within the current or revised fiscal provisions.
