RESOLUTION APPROVING STARS AWARDS RECIPIENTS AND HONORABLE MENTIONS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Board of Supervisors approved a Performance Incentives Program (“San Mateo County STARS”) on December 5, 2006 to recognize and reward County programs that demonstrate outstanding customer service and program performance; and

WHEREAS, in 2008 the Green and Employee Suggestion award categories were added to the STARS Awards Program; and

WHEREAS, sixteen program entries and over twenty suggestions were considered for the FY 2014-15 (10th Annual) STARS Awards; and

WHEREAS, the STARS Review Teams evaluated program entries (for Program Performance, Customer Service and Green award categories) and recommended three STARS Award nominees and four Honorable Mentions for approval to the Board of Supervisors; and

WHEREAS, through the Innovation Summit employee suggestions were reviewed by

County executives and the following suggestions will be implemented if determined viable: Introduce a San Mateo County Commuter Service for employees (Harshil Kanakia and Matt Slaughter, Controller's Office; Michael Bolander, County Manager's Office); Retrofit existing water fountains with hydrations (Tony Crapo, Human Resources/Procurement and Jeff Weaver Parks); Modernize the Accounts Payable process by utilizing new software (Tamara Muccia, Gary Iem, Megan Becker and Angela Sajuthi, Health System) and;

WHEREAS, the Employee Suggestion honorable mention recipients (awarded \$100 per team member) are Pop-Up WIC/CalFresh Clinic- FoodHUB (Jennifer Najarro and Rosavida Cruz, Health System); VRS Community Technology Center (Jeremiah Platon and Ryan Capasso, Human Services Agency); Employee Podcast (Jennifer Logia, County Manager's Office; Jason Escareno, County Manager's Office/Human Resources, and Kristin Barrera, Health System; Clara Kim, Human Resources) and;

WHEREAS, the STARS Awards recipients and amounts for the Customer Service, Program Performance, and Green award categories are: County Library's Summer Learning Camps (\$35,000); Sheriff's Activities League Healthy Kids Programs (\$5,000); Health System's SMMC Green Team (\$5,000) and;

WHEREAS, the recommended STARS Honorable Mention recipients are: Health System's Integrated Medication Assisted Treatment (MAT) (\$7,500); Health System's WIC High Risk Screening and Home Visiting Referral Program (\$7,500); Health System's Coastside Telepsychiatry Program (\$2,500); and Department of Public

Works 555 – 5th Floor Diversion Pilot (\$2,500).

NOW THEREFORE, IT IS HEREBY DETERMINED AND that the Board of Supervisors approve the FY 2014-15 STARS Awards recipients and Honorable Mentions.
