

**AMENDMENT #2 TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
GATES & ASSOCIATES (39000-15-D032)**

THIS AMENDMENT TO THE AGREEMENT, entered into this _____ day of _____, _____, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Gates & Associates, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement (i.e., 39000-15-D032) for landscape planning services for Flood Park on February 23, 2015;

WHEREAS, Amendment #1, an amendment to extend the original Agreement's end date from July 31, 2015 to June 30, 2016, was executed on October 9, 2015; and

WHEREAS, the parties wish to amend the Agreement to revise the scope of work and increase the contract amount by \$14,065 to an amount not to exceed \$114,064.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Section 3: Payments** of the agreement is amended to read as follows:

In consideration of the services rendered in accordance with all terms, conditions, and specifications set forth herein and any Exhibit(s) or attachment(s) attached hereto, County shall make payment to Contractor in the manner specified herein and in Exhibit A. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall total payment for services under this Agreement exceed **One Hundred Fourteen Thousand Sixty-Four Dollars (\$114,064)**.
