**APPROVING THE PESCADERO TRANSFER STATION GATE FEE RATES, EFFECTIVE
FEBRUARY 1, 2016**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County owns the Pescadero Solid Waste Transfer Station that provides solid waste disposal and recycling options to the South Coastal area of San Mateo County; and

WHEREAS, on August 12, 2008, this Board adopted Resolution No. 069636, which approved an agreement with Allied Waste Services to operate the Pescadero Transfer Station from August 15, 2008 through August 14, 2015; and

WHEREAS, on October 23, 2012, this Board adopted Resolution No. 072209, which approved an increase in the PTS gate fees, effective on November 6, 2012; and

WHEREAS, on June 16, 2015, this Board adopted Resolution No. 073887, extending the term of the Agreement for one year from August 15, 2015 to August 14, 2016 and modifying the hours of operation and the Contractor's fee schedule; and

WHEREAS, Public Works staff has evaluated the costs of operating the Pescadero Transfer Station, which is subsidized by the County; and

WHEREAS, the agreement with Allied Waste Services states that the County shall have the exclusive authority to establish the gate fee rates and that such fees collected by Allied Waste Services shall be the property of the County; and

WHEREAS, the agreement with Allied Waste Services states that the County shall have the exclusive authority to establish the gate fee rates and that such fees collected by Allied Waste Services shall be the property of the County; and

WHEREAS, the proposed rate adjustments are a result of community involvement including discussions with the Pescadero Municipal Advisory Council (PMAC), and a PMAC subcommittee to discuss the proposed rates; and

WHEREAS, increasing the Pescadero Transfer Station gate fee rates (Exhibit A) will decrease the subsidy, while continuing to provide solid waste disposal, reuse, and recycling opportunities to residents and the agricultural community of the South Coastal area of San Mateo County.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors approves the Pescadero Transfer Station Gate Rates (Exhibit A) effective February 1, 2016.
