RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD TO EXECUTE
AMENDMENT FOUR TO THE AGREEMENT WITH AMERICAN MEDICAL
RESPONSE WEST FOR PHLEBOTOMY SERVICES TO INCREASE THE MAXIMUM
OBLIGATION BY \$20,000 FROM \$905,910 TO A NEW MAXIMUM OBLIGATION OF
\$925,910

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of
California, that

WHEREAS, the parties entered into an Agreement for phlebotomy services on
May 24, 2005, for services beginning on July 1, 2005 through December 31, 2006 for a
maximum obligation of \$216,000; and

WHEREAS, the Agreement was amended on January 23, 2007, to increase the
maximum obligation by \$180,000 for a new maximum obligation of \$396,000 and
extend the term through December 31, 2007; and

WHEREAS, the Agreement was amended again on December 18, 2007, to
increase the maximum obligation by \$280,410 for a new maximum obligation of
\$676,410 and extend the term through June 30, 2009; and

WHEREAS, the Agreement was amended again on March 17, 2009, to increase
the maximum obligation by \$229,500 for a new maximum obligation of \$905,910 and
extend the term through September 30, 2009; and

WHEREAS, the parties now wish to amend the Agreement to increase the

maximum obligation by \$20,000 from \$905,910 for a new maximum obligation of \$925,910.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute Amendment Four to the Agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.


