ADOPT A RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD TO EXECUTE A FIRST AMENDMENT TO THE AGREEMENT WITH MENTAL HEALTH ASSOCIATION OF SAN MATEO COUNTY FOR THE PROVISION OF

ASSOCIATION OF SAN MATEO COUNTY FOR THE PROVISION OF TRANSITIONAL RESIDENTIAL TREATMENT AND SUPPORTED HOUSING FOR SERIOUSLY MENTALLY ILL ADULTS; HOUSING FOR TRANSITION-AGE YOUTH; FLEXIBLE FUND ADMINISTRATION; AND SCHOLARSHIP FUND ADMINISTRATION, INCREASING THE MAXIMUM OBLIGATION BY \$35,000 TO A NEW MAXIMUM OF \$1,541,843 WITH NO CHANGE TO THE AGREEMENT TERM OF JULY 1, 2011 THROUGH JUNE 30, 2012.

WHEREAS, on May 24, 2011, under Resolution 071404, this Board of Supervisors approved an Agreement with the Mental Health Association of San Mateo County for the provision of transitional residential treatment and supported housing for seriously mentally ill adults who are at risk of homelessness; supported housing for full-service partnership transition-age youth enrollees; and Flexible Funds administration for the period July 1, 2011 through June 30, 2012, for a maximum obligation of \$1,506,843; and

WHEREAS, there has been presented to this Board a First Amendment restoring a budget cut of \$8,000 and funding a "Lived Experience" Scholarship Fund for \$27,000 which the Contractor will administer, increasing the maximum obligation by a total of \$35,000 to \$1,541,843 with no change to the Agreement term.

WHEREAS, this Board has been presented with a form of the First Amendment and has examined and approved it as to both form and content and desires to enter into this Amended Agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said First Amendment for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.
